### 3 BACKGROUND

- 3.1 Mark Tully is a member of both Tranent Amateur Swimming Club and East Lothian Swim Team. He has recently been selected to represent Team Scotland at the 2014 Commonwealth Games in Glasgow in the 50m Breaststroke discipline.
- 3.2 As preparation for the games, Mark will be travelling to France and Spain to train and compete against the world's fastest swimmers. He will be taking part in the World Class Grand Prix circuit in Monty Carlo (7/8 June), Canet (11/12 June), Barcelona (13-15 June) and Sabadel (17-22 June). Mark hopes that this preparation will support his aspirations of winning a medal in his event at the Glasgow Commonwealth Games.
