Please tell us about your organisation and what it does?

Olivebank Child and Family Centre is referral based service which sits within the East Lothian Health and Social Care Partnership. It is Esat Lothian's only child and family centre. We are registered with the Care Inspectorate to provide support to children and their families from birth to school age. Children are offered placements here following presentation at a multi-agency panel and priority is given to those who are most vulnerable as a result of parental substance misuse, alcohol dependency, mental health, parental learning disability, or domestic violence.

Olivebank is a 52 weeks service which enables us to support children and their families all year round. We have the capacity for a maximum of 40 children at any one time. These children are currently organised into 2 rooms with up to 20 children in each room. The Penguin Room supports babies and children from birth to approximately 3 and the Dolphin Room supports children aged 3-5. Both rooms work to the appropriate staff: child ratios. We have 2 groups of children, each attending 2 days either Monday and Wednesday or Tuesday and Thursday. Friday is currently used to provide outreach support to families and undertake group work within the centre. At present we have 49 children registered with us.

Many of our children have experienced trauma in their early lives and as a consequence are often not achieving their developmental milestones. Many of our parents have not had the best start in life themselves and therefore struggled to develop that very important early bond with their babies. Consequently we have children who have attachment difficulties which can result in them having heightened levels of anxiety, being watchful and wary, unable to socialise with other children, struggle to develop trusting relationships and find it difficult to communicate their feelings and emotions. All of these factors are indicators for future difficulties in accessing learning. We therefore focus on our children's emotional health and wellbeing, preparing them for their transition to mainstream education and do this by identifying actions to support this outcome. Staff use a developmental assessment tool which highlights areas where a child may need additional support to achieve their milestones and ensure that we are responsive to the needs of each child. These are shared with parents and reviewed regularly to ensure that the child is able to achieve their full potential. Observations are also used within the playrooms on a daily basis to inform both the planning for the room as a whole and for individual children thus ensuring that the learning environment even for our youngest children is child centred and child led.

We recognise that to achieve positive outcomes for our children we need to work in partnership with a range of people, the most important of whom are the parents. From day one we work hard to build this very important relationship to enable our parents to be the best they possibly can be. We then look outwards to other agencies as appropriate to join the team around the child and these can include Speech and Language Therapy, Educational Psychologist, and Music Therapist all of whom can play an important role in ensuring the child needs are met.

Musselburgh – priority 2, Children living in the Musselburgh area get the best start in life.

Preston Seton Gosford – Outcome 4, Children have the best start in life and can access services they need to help them develop and learn.

East Lothian Plan Outcome 5 – East Lothian's children have the best start and are ready to succeed. Ensuring that children are Successful Learners, Confident Individuals, Effective Contributors and Responsible Citizens.

Please tell us about your project and what you want the grant for?

As stated previously, we work with children who find it very difficult to express their emotions and in some cases understand their situation. To support these children we aim to provide as many as possible with access to a therapies which have been proven to make a difference. The most effective intervention for such young children is music therapy and we would like to be able to provide that for our children on a weekly basis. Music therapy is a client-led intervention based on the understanding that everyone has a natural responsiveness to music. Music can bypass the need for language as a communication medium and its appeal to be used in a communicative way usually remains unimpaired by any physical, learning or emotional difficulty. Music is a powerful tool for reaching into and drawing out the emotional state of a child, helping him or her to accept and work with the feelings that may be confusing and threatening. It can also be extremely motivating for children who lack confidence or have difficulty with and relating to others. It can help a child develop a sense of self, leading to improved self-esteem. It allows a child to explore positive aspects of his or her personality as well as express feelings that are painful or frustrating. It can offer a safe space to explore emotions that may be inappropriate to express in other settings.

This grant will enable me to fund a music therapist for 5hrs per week for 40 weeks from 1^{st} July. On each day she will work on a one to one basis with three of the neediest children at that time and do two small groups with 3 or 4 children in each. These will both be done over 8 - 10 week blocks. By working in this way, almost all of our children will benefit to some degree.

The outcome we seek from this project is that more of our children will be better equipped emotionally to understand what is happening in their lives whether that is about what is happening in their family home or it could be about why they are unable to live with their mummy and daddy. By enhancing their emotional health and wellbeing we would anticipate that they would be ready to learn when they move on to mainstream education.

The music therapist would also lead on staff training which would enable staff to deliver small groups using music as a medium for communication.

The total cost of our project is £5760. I am asking that each Area Partnership contribute on a pro rata basis depending on the number of children from their communities. The breakdown would be:-

Musselburgh -37% = £2131

Fa'side - 40% = £2304

Preston Seton Gosford – 23% = £1325
