If you have concerns about education

If you are worried about your child's education, get in touch with your school or education centre as soon as you can. We can sort out nearly all complaints and concerns at this stage. But, if we can't sort things out, our leaflet Resolving complaints tells you what you can do next.

Other ways of sorting out disagreements

The Additional Support for Learning Act 2004 and 2009 gives children and young people with additional support needs and their parents some new ways to sort out disagreements in cases where there is no formal appeal, for example:

- independent mediation
- dispute resolution
- an Additional Support Needs Tribunal

Independent mediation

Independent mediation is a process where an independent person (a trained mediator) helps the people involved in a dispute to come to an agreement. It allows everyone involved to have their point of view fully heard. The mediator will not discuss what happens at meetings with anyone else and will not offer advice or offer recommendations. This process is voluntary and it is free. **Common Ground** provides this service in East Lothian. Please see Common Ground leaflet for more information.

Dispute resolution (also called independent adjudication)

If other procedures for resolving disagreements have failed, you can ask for independent adjudication. This is a formal review of all the circumstances surrounding your dispute by someone who has expertise in dealing with children who have additional support needs. This person, called an Independent Adjudicator, is appointed by the Scottish Government, and they are not connected in any way with East Lothian Council.

You will have to prepare a case and we will have to prepare one too. The adjudicator will look at all the information about the case and will then write a report with recommendations for you and for us. It is hoped that everyone involved will accept the recommendations, but they are not legally binding.

If you use dispute resolution but your problem is unresolved, you might still be able to use mediation of the Additions Support Needs Tribunal.

Additional Support Needs Tribunal

An Additional Support Needs Tribunal is an independent and expert body that hears and decides appeals (called references) made by parents and young people. It deals with disputes about:

- decisions the council has made about Co-ordinated Support Plans (and failure to keep to the required timescale)
- failure by the council to provide the additional support set out in the Co-ordinated Support Plan
- failure of the council to carry out their planning duties before a young person leaves school
- placement requests to a special school outside East Lothian
- disability discrimination experienced by pupils with additional support needs.



You have to contact the Tribunal to hear your case and then send them all the information that you have. If the Tribunal thinks that you have a case that should be investigated, it will contact everyone involved and arrange a hearing where everyone will have to explain their case. You have the right to take along a supporter or advocate to help you.

There is a free advocacy service to support parents and young people who make a reference to the Tribunal. It is a national service and the Scottish Government have appointed **Barnardo's** and the **Scottish Child Law Centre** to provide it. The service is called **Take Note**. It will provide, in most cases, non-legal representation but in very complex cases legal representation (free of charge) will be provided.

Tribunal hearings will usually take place as close as possible to where you live. At the hearing, a panel of three specially trained people will consider all the information and make a decision about what should happen. The Tribunal will consider all the information and make a decision about what should happen. The Tribunal has the power to ensure that the council carries out what is decided.
