1. Briefly describe the policy/proposal you are assessing.

The purpose of this briefing paper is to provide a position statement on Commercial Sexual Exploitation (CSE) in East Lothian and Midlothian.

This briefing paper was written following a Lothian-wide seminar in 2016 to consider the issue of (CSE) in East Lothian and Midlothian and considers: what Commercial Sexual Exploitation is; legislation and policy; the wider policy context; evidence base; the extent of activity in East Lothian and Midlothian; service responses; service user perspectives; and gaps in support, signposting and information.

It ends with seven recommendations and the Joint Chairs of East Lothian & Midlothian Critical Services Oversight Group (CSOG) have asked agencies throughout East Lothian and Midlothian to review the paper, consider the recommendations and join them in adopting the briefing paper as their Position Statement on Commercial Sexual Exploitation.

2. What will change as a result of this policy?

It is hoped that through review of the briefing paper and consideration of its recommendations agencies within East Lothian and Midlothian will adopt this paper as their Position Statement on Commercial Sexual Exploitation.

This will mean that these agencies along with both CSOG and the East Lothian and Midlothian Public Protection Committee (EMPPC) will support the National Violence against Women Network's view that Commercial Sexual Exploitation is a gendered issue, stemming from gender inequality and is created and maintained by the demand from men to buy sexual access to women.

Further, it is hoped that these agencies will advocate measures that effect a shift in culture and challenge demand for sexual services from women, which includes decriminalising individuals exploited through the sex industry and providing long term support and exiting services for those exploited.

In line with Equally Safe, Scotland's strategy for preventing and eradicating Violence against Women and Girls (2016), CSOG and EMPPC supports a focus on prevention through the delivery of relationship education within the Health and Wellbeing Curriculum and also support the establishment of a legislative framework in Scotland that is founded on addressing the causes of Commercial Sexual Exploitation (i.e. gender inequality and the demand from men to buy sexual access to women).
