Registrations last for 3 years at a time. HMO Licences last for a maximum of 3 years, but can be issued for shorter periods down to as little as 6 months.

HMO's have a discount of 80% for similar or identical footprints of large scale developments (ie. Student Accommodation etc.). 20-% refund of fees on unsuccessful applications.

Property Management and condition is covered by the scheme. There are additional regulations relating to property condition which are governed by the Housing and Property Chamber of the First Tier Tribunal of Scotland and the Health and Safety Executive.
