Following the adoption of the ELLDP 2018, some minor error has been noted within its Written Statement. These are listed below:

- 1) Page 56 in the shaded box for proposal "NK9: Fenton Gait South, Gullane" in the first sentence delete "East" and insert "South".
- 2) Page 147 Policy DP2 point 1 word *palate* should be deleted and replaced with *palette*
- 3) Page 222 Appendix 4 *Schedule of Council Owned* PROP MH16: Whitecraig Primary School Expansion Land should be deleted and replaced with PROP MH16: Levenhall Links to Prestonpans: Area for Habitat Improvement


- 1) Key to Proposals Map
 - Torness Consultation Zone symbol should be outlined in red as it is shown on Map 3
 - Pipeline Infrastructure symbol should be outlined in orange as it is shown on Map 3
 - CH5 Battlefield Sites symbol should be shown with purple vertical lines as it is shown on Map 3
 - RAMSAR NH1 delete "NH1" and insert "Refer to Policy NH1" as on Map 1
 - Geological Conservation Review Sites symbol should be shown with purple diagonal lines as it is shown on Map 1; delete "NH2" and insert "Refer to Policy NH2" as on Map 1
 - Special Protection Areas delete "NH2" and insert "Refer to Policy NH1" as on Map 1
 - SSSI delete "NH2 & NH3" and insert "Refer to Policy NH2" as on Map 1
- 2) Inset Map 3 Landscape and Infrastructure delete designation CH6 (Gardens and Designed Landscapes) Belhaven House as it was removed from the Historic Environment Scotland Inventory of Gardens and Designed Landscapes in 2017
- 3) Inset Map 5 Musselburgh & Wallyford Key delete "MH18" and insert "MH16"
- 4) Inset Map 5 Musselburgh & Wallyford Key insert "1" after "SECF"


Clarification

It has been noted that due to the printing process combining colours from the base map and/or overlays, there is some unintended variation in colour shading on the Proposals Map. This includes some variation in colour shades between some designations and their corresponding colouring on the key(s). For the majority of designations these colour differences are almost indiscernible.

With regard to policy DC1 Rural Diversification, this is represented on the key by a cream colour wash on the Proposals Map. Most of the countryside, other than the Green Belt and when not otherwise allocated for development and therefore subject to their own policy designations, is covered by Policy DC1 designation. Due to the darker colour of some areas of the original background mapping e.g. woodlands, roads or buildings the DC1 cream designation wash appears brown and not the cream wash of the DC1 mapping layer. For the avoidance of doubt these brown areas in the countryside do not represent any allocation or proposal; they are continuation of the DC1 designation.

Fig 1 below illustrates these variations of colours with the brown areas of existing woodland and roads outwith New Winton which are covered by Policy DC1 designation. The settlement of New Winton is defined by the extent of Policy RCA1 designation.





For similar reasons the designated areas of Mineral Safeguards within Inset Maps 40-43 have reproduced as brown and not grey as the key indicates, however, the boundaries are clearly denoted as shown on Fig 2.
