	IR reported that following agreement with Tarmac a new shared use cycle path was now in the final	
	stages of construction, estimated to be completed and open for public use by the end of February. The	
	new path will form a new realigned section of the NCN Route 76 which Sustrans is also contributing	
	funding to. This shared use path and another footpath currently being considered around the quarry,	
	are part of the former quarry's Restoration Plan.

	Sustrans Places for Everyone Fund 2021-22	
	IR reported that at the time of the meeting ELC were awaiting the result of a funding application	
	submitted to Sustrans that if successful would allow further road and crossing design option studies	
	to take place for the Drem to Gullane path. These studies will focus on a key section of the proposed	
	route for access/egress north of Drem Village.	
	Note: Since the Forum meeting ELC have been informed by Sustrans that their application has been

	Musselburgh Active Toun (MAT)	
	This project involving identifying and developing key strategic cycle routes in and around	
	Musselburgh. The results of early community consultation and engagement along with traffic	
	monitoring and data collection are still being analysed. The MAT project has a number of the routes	
	around the River Esk that have a synergy with the Musselburgh Flood Protection Scheme. <b>NH</b>	
	informed the meeting that the Scottish Government has paused all these types of flood protection	
	schemes across Scotland, and are currently conducting a review and ELC will have to await the	
	outcome of that review and any future funding decisions.	IR

#### Safer Routes to Schools North Berwick & Shore Road, Belhaven Traffic Study

**IR** reported that following detailed design works by a consultant on behalf of ELC a number of interventions had been identified that would improve walking and cycling infrastructure making it easier and safer for the journey to North Berwick High and Primary schools, and soon to be built new Nursery . An application for funding for these interventions was submitted to Sustrans who after a review requested further details once that is received from the consultants the application will be resubmitted. It is anticipated that if successful, any construction works are likely to be in Summer 2022 to avoid any impact on the school community.

# Belhaven Village/Back Road

**NH** Reported that in view of the range of road network issues around Beveridge Row, Shore Road, Back Road and Belhaven Village in he had requested that a transport consultant is commissioned to conduct a traffic study in this area to provide a report and plan on what can be done to address them including improvements to walking and cycling to include the lack of a footpath on Back Road. **MJ** mentioned that the gradient on Back Road was quite steep and that to address that a zig zag path design may be required.

# Sustrans, 'Places for Everyone ' projects 2021-22

The **Hospital Road, Haddington** project for a new shared use path is in ELC's roads programme with construction to commence late January 2022. Once completed this will connect to the **Haddington to Longniddry Railway Walk (NCN76) – Community Hospital section** which

**NM** reported will now be funded from the Sustrans Cycle Network Fund which provides 100% funding to projects in this category. A planning application for this new section will be submitted soon and once approved construction could commence in late Summer this year.

#### E-Bikes at Musselburgh

CM reported that with the restrictions posed by the pandemic he is now looking at ways to promote these bikes as we head towards Spring. To date, without any focused promotion there has been over 1000 individual hires, mainly from the Musselburgh Stations at the Rail Station and Brunton Hall. He is looking at ways and options to expand and promote the stations and has been discussing this with SEStran and Bewegen. Additional funding has been secured from Sestrans and European Share North Fund to expand the network around Musselburgh initially to make more point to point journeys. Currently discussion ongoing with Eskmills Business Park, Tesco and Musselburgh Sports Centre to locate a new type of docking station at their locations which are easier to install and have an element of security included. Other locations are being considered in the county including proposed Journey Hubs. Presently awaiting the outcome of a funding bid to the Energy Savings Trust that would provide a further 20 ebikes and 2 e cargo bikes. **DW** asked if there was plans to have bikes to spread around Musselburgh. CM said he is in discussion with Queen Margaret University and using the new docking station it may be possible if successful for more stations to be created that will provide a wider geographic spread. HL asked if there was any data on who and what the bikes are being used? CM said that unfortunately other than 'point to point' no other data is currently available but he has raised this with Bewegen as it would be useful to know more about the type of journey, commute, leisure etc. which could also inform the locations for future docking stations. NH asked if a docking station could be at Wallyford Rail Station that would allow cycle hire connectivity to Newcraighall Stations which operate separate rail line routes. CM reported that there are plans ongoing to develop the Wallyford 'Park and Choose' into a Journey Hub and ebikes can be included.as one of the transport modes. Replying to a question from MJ, CM reported that the bikes maintenance 'rebalancing' is provided via Sestran by a company based in Stirling and whilst efforts have been made to identify a more locally based company to undertake those duties, to date this has been unsuccessful. NH commented that as the scheme expands there may opportunities for that company to have a base in East Lothian.

# **QMU to Old Craighall Cycle Route - SATC**

IR reported that there are three rail underpass sections where resurfacing requires to be completed and discussions are ongoing with Network Rail who control any works underneath the railway line with their consent required before any works can commence. This includes a power supply connection for the path lighting and progress is being made to make that connection. **DW** asked how the path connects at Old Craighall and IR reported that as part of the path works a new path would be constructed to connect to Monktonhall Place and the existing NCN1 route,

**NH** added that a similar issue with Network Rail at Dunbar at the Dunbear site and an underpass which has resulted in that underpass recently being resurfaced however there remains an issue of path lighting to be resolved.

# The Drift Path cycle route – connection to Pinkie

**IR** reported that the final connecting section of The Drift cycle path was now almost fully constructed and **DW** asked if signage could be put in place to make the public aware of where it connects to and that it is for shared use and asked if there were any plans to make a new path connection southwards from the underpass to Crookston. **IR** said he will request new signs and currently there are no plans at this time for any path improvement south from the underpass, however transport planners are aware of a need for that connection and when that site is being developed path improvements are included as part of any planning conditions.

#### De-signed section of the NCN routes in East Lothian

**IR** reported that the council are waiting for a report from Sustrans Officers following which there will be further discussions with them to explore options how best to address the issues and progress to have them reinstated.

#### **Pump Tracks**

**NH** said there was a lot of growing interest in Pump Tracks in East Lothian with the most recent one opened at Ormiston Park and with others being considered for North Berwick, Dunbar and Haddington with officers looking at ideas for Tranent and Musselburgh. He asked the Forum members to give their support for them in their local area. They are very popular with young people with many travelling to access them and a desire to have one closer to where they live. There have been reports from the Ormiston Track with so many young people using them there has been an improvement in the behaviour of some of the young people using their energy there rather than in other ways in the community. Pump Tracks can be a gateway activity to skateboarding and BMX and cycling.

The council are very keen to spread these facilities across the county and officers are working with Sports Scotland on funding and identification of potential sites with any site proposals need to be supported by the communities to allow them to be developed.

# 4. <u>East Lothian's Sustainability & Climate Change Officer</u>

HL informed the meeting that she had recently taken over this role from Jennifer Lothian and she is responsible in the council for carbon reporting to the Scottish Government. In relation to the Forum she is responsible for updating the Council's Climate Change Strategy and Action Plan which contains a number of cycle related actions. **DW** asked if we had any data on cycle levels in East Lothian to measure if cycling numbers are increasing which from his own experience he is seeing more cyclists in the Musselburgh area and it would be good to capture any formal data especially with all the new infrastructure being put in place. **HL** said that Bikeability does give an indication not only for young people at schools but also for some adults. **IR** reported that whilst there are monitoring equipment on path locations many are old and not reliable and needing upgrading. A new walking/cycling counter has been installed on the new SATC at the QMU. There has been a number of sites in towns across the country where temporary traffic monitors, including video have been installed which informs transport planning. **CM** added that there will be an additional 8 multi modal traffic counters installed in the coming months two of which will be at the Journey Hub at the Brunton Hall and Wallyford Park and Choose with other locations still to be confirmed. These will add to the existing data information along with the annual National Hands Up Survey for schools and provide more accurate data on cycling numbers across the county.

**DW** asked if there was an opportunity to have volunteers conduct face to face surveys at key locations perhaps once or twice a year. **NH** suggested this could be done via social media and also include the local Area Partnerships.

**HL** mentioned that there was an online tool bioblitz, where communities and volunteers gathered information on plants and wildlife, and it could be adapted and utilised to gather cycle data. <a href="https://nbn.org.uk/tools-and-resources/useful-websites/national-bioblitz-network/">https://nbn.org.uk/tools-and-resources/useful-websites/national-bioblitz-network/</a>

**MJ** commented that he and others in the past had went out regularly to conduct counts surveys in Dunbar, albeit the results were fairly 'flat'. **MH** commented that Cycleforth would be happy to be involved in any survey.

# 5. Quiet Roads

IR reported that since the last meeting discussions have taken place with Sustrans with a view to the Braeheads road, part of the NCN76 that connects to Hailes Castle and East Linton to be considered as a pilot as a 'quiet road' where walkers, cyclists and equestrian users are highlighted for vehicle drivers. These discussions are at an advanced stage with details of the signs to be used to be agreed. It is hoped that following the trial period and if successful other similar roads in East Lothian could be considered and categorised and signed, encouraging the public to use them for active travel. MH from Cycleforth who had asked for this item to be discussed asked what the mechanism would be to have roads identified and categorised as 'quiet roads'. IR said that whilst there is a national policy on vehicle speeds there is not one on 'quiet roads' and each LA can introduce their own measures commensurate with their geographic and road network use which align with the national policy. The inclusion of 'Quiet Roads' in the new ELC draft policy for the proposed speed limits in the county will be made available in due course for public consultation and shared with Forum members and if approved will inform transportation colleagues on the process to have roads treated as a 'quiet road'. DW added that he had seen a similar signage in Aberdeenshire and he had some locations for example the Fa'side castle road which is used by walkers and cyclists. MJ suggested that in future a map could be created of these 'quiet roads.' and MH suggested that once established they could be promoted for cycle tourism.

# 6. Any other Business

# Signs connecting to Dunbear Park, Dunbar

**MJ** asked if there had been any progress for signs from the new Macgregor Homes at Dunbar. **NH** has requested signs from the cycle path via the development to Dunbear Park.

#### **Cycle Parking Dunbar**

**MJ** had heard from a resident in Dunbar asking about cycle parking in areas in Dunbar close to the High street and also the Splash Leisure Centre. **NH** asked if a list of locations could be provided and shared with the Area Partnership which could assist.

# **Dunbar Newsletter**

**MJ** helps produces a Dunbar newsletter and if any Forum members have any information they would like to share if they can contact him.

#### **Demonstration Project – Electric Cargo Bikes**

**CM** reported that he had contacted Area Partnerships about organisations that would be interested in trialling electric cargo trikes and had asked for notes of interest. There has been a very good response mainly from community based organisations and charities and not businesses. He has been in discussions with Raleigh and Sustrans and another supplier XYZ a company who have 'modular' cargo bikes, all with a view to providing these bikes. Now that there is a demand for a trial he will in the coming months. In the interim he has decided to extend the period for notes of interest by a further 4 weeks and will be circulating an email with details to the Forum soon and would hope to commence a demonstration project from May this year onwards. If anyone knows of others who may be of interest put them in contact with Chris.

# **Progress with the SATC**

**IP** asked what progress there had been on the Segregated Active Travel Corridor. **IR** referred to the QMU section in Matters Arising, also a short section to be delivered by the housing developer at Macmerry. Prior to the pandemic he and Aecom had been in discussions with landowners west of The Drift Path towards Inveresk and that remains to be progressed. The proposed SATC is over 20 miles in length and consequently it will be a long process to deliver the high quality cycle route that is envisaged and due to financial restraints this will be done in short sections as an when opportunities arise, for example at Strawberry Corner, Wallyford. The SATC is referred to in the LDP1 and will feature in the LDP2 and where possible new developments will contribute to the delivery of this cycle route albeit over a long period of time, as and when funding and opportunities arise.

# Cycle Path Maintenance

**MH** highlighted a recent incident when cycling to Gullane on the cycle path where he had to leave the path and join the road due to path being covered with cuttings from the adjacent hedge that had

been recently cut and who was responsible to remove the cuttings. **NH** suggested that the responsibility should lie with the landowner and if they fail to clear up after any hedge cutting/pruning a complaint can be lodged with the council who would try to resolve the problem by contacting the landowner. #### 7. Bikeability Update

Following the meeting PB supplied a summary report on Bikeability activity in East Lothian -

Funding received by East Lothian Council Outdoor Learning Service from national cycling charity Cycling Scotland, has supported over 600 primary children through on road cycle training, Bikeability Scotland Level 2, in five months. Another 700 pupils will complete before Easter. More will complete during the summer term, supporting 28 of 34 ELC primary schools. This provides the majority of P7s, and many P6s with quality on road cycle training. Connected Communities in Tranent support cycle training in the cluster, including targeted projects and learner cycling. An iBike Officer role in Musselburgh, funded by Sustrans, has introduced a range of active travel projects, including cycling and scooting skills sessions in schools. Working alongside the Outdoor Learning team, Bikeability Scotland Level 2 was delivered in Campie and Wallyford, with more plans developing across the cluster to embed Bikeability Scotland and active travel programmes.

**NH** said the next meeting is planned for May, which coincides with the local elections therefore the next meeting will be after their conclusion with the Forum Chair subject to potential change as a consequence of the election results.
