

## Provisioning Strategy Project Reference Group, Terms of Reference

# "Be part of the conversation. Planning older peoples' services in East Lothian"

#### 1. Remit

The East Lothian Provisioning Strategy Reference Group will act as a 'critical friend' and assist in the co-production of options throughout the life of the engagement and consultation process. It will:

- Be a partner in coproducing the governance of the consultation process.
- Maintain an overview of engagement materials and methods to ensure appropriateness and inclusivity.
- Review progress of the engagement programme.
- Review feedback and evaluation from events.
- Propose changes to the engagement programme, methods and materials they feel to be necessary.
- Participate in the Options Appraisal and Integrated Impact Assessment process.
- Contribute to the final evaluation of the engagement programme.

#### 4. Frequency of Meetings

The Steering Group will be a short life working group that will meet approximately monthly for a period of eight months from August 2023.

#### 5. Key responsibilities

- Advise on appropriate engagement methods and techniques for the groups they represent.
- Review communications for the communities they represent and advise on appropriate communication formats and channels.
- Review feedback and ensure that it reaches participants in appropriate formats.
- Take part in some engagement sessions to gauge how effective they are and to ensure that feedback is being recorded and analysed accurately.
- Advise on barriers to access to engagement.
- Seek to raise awareness of the engagement within communities and professionals they represent.
- Act as a critical friend to the options appraisal process.

### 6. Communication and Engagement

Effective communication and engagement is recognised as a key component of this project and as such providers / advocates will be invited to sit on the steering group to inform the development of the strategic plan. Two Integrated Impact Assessments will also be undertaken as part of this work.

#### 7. Governance and reporting arrangements

The short life Reference Group will report to the Provisioning Strategy Project Team on the progress and efficacy of the engagement programme. Progress updates on the engagement, together with draft feedback reports and newsletters will be presented to this group on a regular basis and they will be engaged in the options appraisal process. They will also be asked to take part in Integrated Impact Assessments.
