When is your rent due?

Paying rent is the most important part of your Tenancy Agreement. It is important that you pay your rent on time and in full.

Rent is charged fortnightly and is payable in advance by the first Monday of each rent period. Any payment not made on time will be treated as arrears.

Rent payment breaks

If you have an up-to-date rent account, you can benefit from a rent payment break:

- Fortnight starting 26 June 2024
- Fortnight starting 25 December 2024
- Week starting 31 March 2025

If you have rent arrears, you will not qualify for these payment breaks and must continue to pay towards your arrears.

Direct Debit

Set up a Direct Debit, it's the easiest way to stay on top of your bills.

Direct Debit offers an easy hassle-free way to pay your regular outgoings, helping to avoid rent payments being forgotten.

You can set up your instalments to pay:

- fortnightly at the start of each rent period
- monthly on the 8th, 16th, 23rd or last day of the month
