Developing the aims and objectives for health and social care services

What is the East Lothian Integration Joint Board?

East Lothian Integration Joint Board (IJB) is responsible for the planning and commissioning of a range of community health and social care services in East Lothian (these are referred to as 'delegated services' and are shown in the background information table below).

The IJB is required to develop a Strategic Plan outlining its strategic direction and key objectives for the delivery of these delegated services.

The IJB issues directions to the East Lothian Health and Social Care Partnership, which brings together teams across East Lothian Council and NHS Lothian who work side-by-side to deliver health and social care services in line with the IJB's Strategic Plan. Some services are also delivered on a commissioned basis (by private contractors and third sector partners) or are delivered by NHS Lothian wide managed services.

Developing the IJB Strategic Plan

The Strategic Plan sets out the IJB's strategic objectives and delivery priorities for the next 5-years (2025-2030) and provides a framework for IJB decision making, including in relation to the use of financial and other resources. The Strategic Plan is also important in terms of communicating the IJB's strategic priorities to staff, partners, and other stakeholders.

Details of the activity planned to deliver the Strategic Plan objective is contained in the Annual Delivery Plan – this is reviewed annually and updated in response to any new developments or changes, including to reflect the IJB's financial position.

The Strategic Plan explains:

- the context in which the plan exists, such as the current social, economic, demographic and health challenges of East Lothian,
- the anticipated needs of the local population, based on available evidence and local data and
- how the IJB aims to focus its decision-making and allocate the available resources to
 ensure service delivery meets the health and social care needs of the people of East
 Lothian.

The strategic planning process and how you can participate

The IJB is required to produce its strategic plan in cooperation with the community. This means asking for ideas, feedback and comments on the content of the plan throughout its

development. The IJB must carefully consider the views of the community when putting together its final strategic plan and explain its decisions.

Stakeholder engagement on the current strategic plan draft has been underway since late 2024 through the Strategic Planning Group and via other channels. Feedback received has led to the co-creation of a set of draft aims and objectives. In August, September and October 2025, this engagement will extend to everyone in East Lothian to gather community opinions on whether the IJB has understood community needs and priorities for health and social care.

East Lothian Context

Demography and population

- The projected population increase from 2018-2043 is estimated at 15% (approx. 16,000 people)
- The largest growth will be in the older population groups (40.8% in over 65 years, and 93.4% in over 75 years)
- An increase in the older population is of particular significance in terms of their higher use of health and social care services. 77% of people receiving social care support in Scotland are 65 and over.
- The rise in the proportion of people living with multiple long-term conditions (MLTCs) (21.3% in 2022 census) has been identified as one of the most significant challenges facing health services, both currently and in the coming decades.

Health inequalities

- There is a strong relationship between life expectancy and deprivation, with higher deprivation being linked to lower life expectancy.
- There are a range of drivers that impact health and wellbeing outcomes:
 - Social and economic factors (40%): education, employment, income, family and social support, community safety,
 - Environment (10%): housing, transportation, air and water quality
 - Health behaviours (30%): alcohol, smoking, drug use, diet, physical activity, sexual activity
 - Health and social care (20%); access to care and quality of care
- IJBs have a lead role in the strategic planning and commissioning of accessible, good quality local health and social care services, as well as working as part of a wider system approach to improving health and wellbeing.

Financial context

- Across the country IJBs continue to face pressure on budgets, having to achieve savings year on year.
- East Lothian has already made difficult decisions regarding service provision. However financial projections indicate further savings and reductions will be required in the future.
- The IJB are focused on delivering services within budget while ensuring that services continue to reduce harm and keep people safe.
- Continuing to invest in prevention and early intervention approaches to support people
 to live healthy lives and self-manage their conditions, has been identified as priority to
 mitigate the likely rise in service demand resulting from demographic pressures.

Strategic Objectives
