#### Methodology:

##### **Quality assessment summary for each Cluster Area:**

The Quality of each open space was audited under the following categories (see details in Table 2 of the main Technical Report):

- Access & Community
- Attractiveness / Place Appeal
- Biodiversity
- Functionality
- Community Benefits
- Tackling Climate Change

#### **Quality scoring:**

Each open space was assigned Quality scores of between 0 to 5 (where 0 = 'not present' / lowest quality to 5 = highest quality) for the range of categories assessed in the audit. An average Quality score for each site was then calculated as the percentage of the total maximum possible score. This was applied consistently across all **462 open spaces** in the Open Space Audit 2024/25. The fitness for purpose of each site was categorised as shown below:

## **Dunbar Cluster**

The Dunbar Cluster area includes Dunbar and the villages of East Linton, Stenton, Innerwick, Spott and Oldhamstocks. Dunbar has a growing population and good road and rail links to Edinburgh and the south. East Linton has a growing population and a new railway station on the East Coast Main Line. The Cluster includes the small villages of Stenton, Innerwick and Oldhamstocks, which are located in the foothills of the Lammermuir Hills.

### **Public Parks and Gardens**

The Dunbar Cluster includes the only designated Country Park in East Lothian: John Muir Country Park. The Cluster includes the destination park of Lauderdale Park in Dunbar, which has had significant improvements since 2018 including a new inclusive play area, Winterfield Park in Dunbar and Memorial Park in East Linton, which have had improvements including 'Nature Network' enhancements. New privately owned parks, greenspaces and playspaces have recently been constructed in Dunbar and East Linton in new housing developments.





#### Accessibility assessment (distance thresholds):

- **Public Parks:** Most areas of Dunbar Cluster have good access to public parks, including John Muir Country Park, with a combination of existing and new Town Parks and Local Parks, with the exception of the south-eastern area of Dunbar, which is the new housing development constructed through the current Local Development Plan 2018 – this residential area falls outwith the Public Parks catchment areas and is currently still under construction.
- **Sports Pitches and outdoor sports facilities:** All areas of Dunbar Cluster meet the 2026 Cluster Provision standard for Sports Pitches and outdoor sports facilities.
- **Equipped Play Areas:** Dunbar Cluster meets the accessibility standard distance threshold for Equipped Play Areas.

#### Sports Areas Actions

Proposed actions to improve local and regional sports provision:

- Current and future demand will be met for cricket, rugby, hockey, tennis and bowls.
- All residential areas within the cluster fall within the 2026 ELC accessibility standard for sports areas of 'Provision within the Cluster Area'.
- Further sports enhancements at Hallhill are due to be delivered with developer contributions, specifically 1 x full size grass sports pitch and 2 x team changing extension to Hallhill Healthy Living Centre.
- An assessment of future need for this Cluster will be undertaken to assess the requirements for sports provision based on the anticipated housing allocations and locations identified in the emerging Local Development Plan 2.
- Future developer contributions should be based around **Cluster wide sports provision**.

## **Haddington Cluster**

Haddington is the second largest town in East Lothian, and the administrative headquarters for the Council. There are a number of smaller villages scattered throughout the inland area including Athelstaneford, Bolton, East Saltoun, Garvald, Gifford, Drem and Humbie. This cluster area extends to the Lammermuir Hills in the south and the historic villages of Gifford and Garvald.

### **Public Parks and Gardens**

The Haddington Cluster includes the destination park of Neilson Park in Haddington, which has had improvements since 2018 including a new upgraded play area. Other parks in the cluster area have had improvements including 'Nature Network' enhancements. New privately owned parks, greenspaces and playspaces have recently been constructed in Haddington in new housing developments.





## **Musselburgh Cluster**

Musselburgh is East Lothian's largest town, and borders the City of Edinburgh. The cluster has experienced significant growth. Large scale housing developments are underway in the Musselburgh and Craighall areas. Musselburgh, Inveresk and Wallyford are adjoining communities, located in the north-west of the county. A high number of residents commute to Edinburgh for employment. Wallyford is a former mining village, which has experienced significant expansion recently with the development of new housing areas. To the south are the villages of Whitecraig and Old Craighall; both have experienced new housing developments in recent years.

### **Public Parks and Gardens**

The Musselburgh Cluster includes the destination park of Lewisvale Park in Musselburgh, which has had significant improvements since 2018 including a new play area particularly aimed at older children and teens. Other parks in the cluster area have had improvements including 'Nature Network' enhancements. New privately owned parks, greenspaces and playspaces have recently been constructed in new housing developments across the cluster.





- **Equipped Play Areas:** Musselburgh Cluster meets the accessibility standard distance threshold for Equipped Play Areas.

#### Sports Areas Actions

Proposed actions to improve local and regional sports provision:

- New community sports provision at Craighall resulting from the new development site comprising 3 grass football pitches, has recently been completed on site. A team changing facility is still to be provided on site.
- A new 1 x full size grass sports pitch and 2 team changing pavilion linked to new full sized sports pitch are due to be provided in Whitecraig resulting from the Whitecraig South and Whitecraig North housing developments.
- Current and future demand is met for cricket, rugby, hockey, tennis, shinty and bowls.
- All residential areas within the cluster fall within the 2026 ELC accessibility standard for sports areas of 'Provision within the Cluster Area'.
- An assessment of future need for this Cluster will be undertaken to assess the requirements for sports provision based on the anticipated housing allocations and locations identified in the emerging Local Development Plan 2.
- Future developer contributions should be based around **Cluster wide sports provision**.

## **North Berwick Cluster**

North Berwick is located on the coast in the north of East Lothian. The town has a growing population and people commuting to nearby centres of employment. To the west, the attractive historic villages of Aberlady, Gullane and Dirleton follow the coastal road, and the small village of Whitekirk is to the south. The area's settlements are set in high quality landscapes, and are largely composed of conservation areas. This area forms a focal point for tourism and recreation (particularly golf and coastal access) within East Lothian. All of the towns and villages in this cluster have experienced new housing developments in recent years.

### **Public Parks and Gardens**

The North Berwick Cluster includes the destination park of Lodge Grounds in North Berwick, which has had improvements since 2018 including seating and picnic tables, landscaping and 'Nature Networks' enhancements. New play areas have been constructed in the Pleasance in Aberlady and Memorial Park in Gullane. Various parks in the cluster area have had improvements including 'Nature Network' enhancements. New privately owned parks, greenspaces and playspaces have recently been constructed in new housing developments across the cluster.





#### Accessibility assessment (distance thresholds):

- **Public Parks:** Most areas of North Berwick Cluster have good access to public parks, with a combination of existing and new Town Parks and Local Parks, with the exception of the north-west of North Berwick – this residential area falls outwith the Public Parks catchment areas; it is mainly a historic area of older housing with large gardens.
- **Sports Pitches and outdoor sports facilities:** All areas of North Berwick Cluster meet the 2026 Cluster Provision standard for Sports Pitches and outdoor sports facilities.
- **Equipped Play Areas:** Most areas of North Berwick Cluster meet the accessibility standard distance threshold for Equipped Play Areas, with the exception of the northern area of North Berwick. This is the older area of North Berwick around the town centre and closest to the coast. The addition of new equipped play provision (LEAPS) in several locations in the new housing developments in North Berwick, consented through LDP 2018, have contributed to a greater distribution and provision of play areas in the west and south-west of North Berwick.

#### Sports Areas Actions

Proposed actions to improve local and regional sports provision:

- Current and future demand met for cricket, rugby, hockey, tennis and bowls.
- All residential areas within the cluster fall within the 2026 ELC accessibility standard for sports areas of 'Provision within the Cluster Area'.
- Overall provision within the town is sufficient at strategically located sites to suit the town's current needs. Possible modification of existing infrastructure to accommodate adult football teams may be necessary in the future.
- Enhanced sports provision will be delivered in Gullane resulting from the new Saltcoats and Fenton Gait housing development sites, comprising improving the quality of the existing 11 a side grass pitch in Recreation Park (levelling/drainage) to take account of increased usage, and construction of a new additional 7 a side football pitch on land south of the school site.
- In Aberlady, developer contributions arising from the Aberlady West housing development will comprise improved drainage to increase capacity and usage of existing 11 a side grass pitch.
- An assessment of future need for this Cluster will be undertaken to assess the requirements for sports provision based on the anticipated housing allocations and locations identified in the emerging Local Development Plan 2.
- Future developer contributions should be based around Cluster wide sports provision.

## **Prestonpans Cluster**

The Prestonpans Cluster includes the coastal settlements of Longniddry, Cockenzie, Port Seton and Prestonpans. Prestonpans has experienced expansion in recent years with a new housing development on the south-west of the town, and Longniddry is currently experiencing expansion to the south side of the railway line. The cluster includes the former Cockenzie Power Station site, which is a focus for future economic growth. Meadowmill Sports Centre, a sports / athletics facility of regional significance, is located in this cluster.

The new town of Blindwells is currently under construction. For convenience it has been included in the Prestonpans Cluster at this stage while it is under development.

### **Public Parks and Gardens**

The Prestonpans Cluster includes a number of Town Parks, including Cemetery Park and Cuthill Park in Prestonpans, King George V Park in Cockenzie & Port Seton, and Longniddry Park. Various parks in the cluster area have had improvements including 'Nature Network' enhancements. New privately owned parks, greenspaces and playspaces have recently been constructed in new housing developments across the cluster.





- An assessment of future need for this Cluster will be undertaken to assess the requirements for sports provision based on the anticipated housing allocations and locations identified in the emerging Local Development Plan 2.
- Future developer contributions should be based around **Cluster wide sports provision**.

## Blindwells New Settlement

Approximately 130 hectares of land at Blindwells, near Tranent, is currently under construction for the development of a new settlement comprising land capable of accommodating 1600 houses, commercial, social, educational and community facilities, open space, employment and associated infrastructure.

#### Sports Areas Actions

The sports provision requirement for Blindwells is:

- 3 full size community sports pitches
- 3 full size tennis courts
- 1 cricket wicket
- changing pavilion.
- An assessment of future need for this Cluster will be undertaken to assess the requirements for sports provision based on the anticipated housing allocations and locations identified in the emerging Local Development Plan 2.
- Future developer contributions should be based around **Cluster wide sports provision**.

## **Tranent Cluster**

The Tranent Cluster includes the inland settlements of Tranent, Macmerry, New Winton, Elphinstone, Ormiston, Pencaitland and Gladsmuir. Tranent, Macmerry and Elphinstone are former mining settlements which have all experienced recent growth due to new housing developments currently underway. New housing developments have also recently been constructed in Pencaitland and Ormiston in the rural south of this cluster area.

### **Public Parks and Gardens**

The Tranent Cluster includes the destination parks of Polson Park in Tranent, which has had improvements since 2018 including a new commemorative garden and 'Nature Network' enhancements, and Ormiston Park, which has had significant enhancements driven by the 'Friends of Ormiston Park' community group and the construction of the county's first large-scale Pump Track. New inclusive play areas have been constructed recently in Muirpark (Ormiston Road) in Tranent and Pencaitland Park. Various parks in the cluster area have had improvements including 'Nature Network' enhancements, and new seating, including Memorial Park in Elphinstone. New privately owned parks, greenspaces and playspaces have recently been constructed in new housing developments across the cluster.












