2.1 Cabinet is asked to note the decision of the Executive Director (Services for Communities) (per the Head of Housing & Environment) as appointed representative under Standing Order Rule 46 and delegation Appendix 2a (Tenders) thereto and after consultation with the Head of Council Resources to accept Messrs Bankton Development's tendered Schedule of Rates amounting to £28,790.00 after checking and noting that it is open for consideration until 15 October 2012 for Proposed Waste and Refuse Clearance from Travelling People Sites, East Lothian 2012/2013.

### 3 BACKGROUND

- 3.1 The Council is proposing to appoint through competitive tendering, a single contractor to clear refuse and waste left behind at Travelling People sites throughout East Lothian. The Contract will run until 30 March 2013 and will enable the Council to react quickly to unwanted waste situations.
- 3.2 Tender Documents were issued to Three Specialist Contractors via the Public Contracts Scotland Quick Quotes facility and the following offers were duly received, all being subjected to detailed checks resulting in the Tender Amounts indicated overleaf:

- 3.3 As indicated at 3.2 Messrs Bankton Developments Ltd's tendered Schedule of Rates amounting to £28,790.00 after detailed checking remains the lowest of the offers submitted and has been competitively priced throughout.
- 3.4 Messrs Bankton Developments Ltd have indicated that they do not intend to sub-contract any of this work.
- 3.5 The Contract is prepared on a remeasurement basis in terms of the Conditions of Contract contained with the Contract Document and the Contractor has undertaken to carry out the work up until 30 March 2013.
