SUBJECT: Amended Speed Limits - B6471 West Road and A199

Haldane Avenue, Haddington

1. PURPOSE

1.1 To seek Cabinet approval to commence the statutory procedure necessary to introduce a Traffic Regulation Order to amend speed limits at the locations listed in Appendix A.

2 RECOMMENDATIONS

2.1 That Cabinet approves the initiation of the statutory procedure necessary to introduce a Traffic Regulation Order in accordance with 'The Local Authorities' Traffic Orders (Procedures) (Scotland) Regulations 1999 as per attached Appendix A and location plans.

3 BACKGROUND

- 3.1 East Lothian Council as Local Traffic Authority is responsible for the making or amending Traffic Regulation Orders as necessary; to avert danger to road users; to prevent damage to the road; to aid free unrestricted movement on the road; to prevent inappropriate use of the road and/or adjoining property and to improve the amenity of the area.
- 3.2 B6471 west side of Haddington the amended speed limit is required to facilitate access for the new Sainsbury's supermarket traffic signal junction.
- 3.3 A199 Haldane Avenue 40mph speed limit extended westwards to enhance road safety.
- 3.4 Police Scotland will be fully consulted on the introduction of these proposals.

4 POLICY IMPLICATIONS

- 4.1 These proposals are expected to contribute towards providing a Safer Environment a key priority for East Lothian Council.
- 4.2 These proposals are expected to contribute towards East Lothian's Single Outcome Agreement Outcome 9 East Lothian roads will be safer for all users.
