Comment

If licences are to apply nationally, universal mandatory conditions would be required as opposed to the current imposition of local conditions that attach to licences. Legislation applying in Scotland often does not apply in England, Wales and/or Northern Ireland and vice versa. Furthermore, breach of licence conditions is a criminal offence and applicability may cause difficulties given the different criminal law in Scotland. The proposal at 2.13 would have to introduce a fee to cover the work involved in dealing with registration checks.

Personal Licences in terms of the Alcohol (Scotland) Act 1976 would not be suitable for national (UK) applicability because of the different legislation in Scotland.

The consultation has not distinguished adequately between the possible applicability of licences across authorities in the same jurisdiction (e.g. Scotland) and between different jurisdictions within the same state (e.g. between Scotland and England within the U.K.). It is not just the lack of authority in another part of the UK that is at issue; it is that different laws apply.
