1 PURPOSE

1.1 To note the decision to award the contract for the Proposed Alterations and Extension (Stair Enclosure and Lift) at Macmerry Primary School, Macmerry to Messrs Hadden Construction Ltd, Auchterarder.

2 **RECOMMENDATIONS**

- 2.1 Cabinet is asked to note the decision of the Executive Director (Services for Communities) (per the Head of Housing & Environment) as appointed representative under Standing Order Rule 46 and delegation Appendix 2a (Tenders) thereto and after consultation with the Provost and the Head of Council Resources to accept Messrs Hadden Construction Ltd's tender amounting to £395,905.40 after checking and correction and noting that it is open for consideration until 20 May 2013 for the Proposed Alterations and Extension (Stair Enclosure and Lift) at Macmerry Primary School, Macmerry.
- 2.2 Cabinet is asked to note that the Executive Director (Services for People) has approved the award of this Contract.

3 BACKGROUND

3.1 The Council intends to extend the accommodation at Macmerry Primary School to provide sufficient and improved teaching space for the beginning of the 2013/14 session. The proposed extension will provide a new school entrance, stair and lift access to the first floor which will enable use of an additional classroom in compliance with Fire Safety Regulations and DDA. The works will also provide a First Aid Room for the school, Library and GP space and storage for resources.

The works will commence on site in March 2013 with completion by 16 August 2013.

3.2 Tender Documents were issued to the seven undernoted Lot 2 Framework Contractors and the following offers were duly received, the lowest three being subjected to detailed checks resulting in the Tender Amounts indicated below:

3.5 The Contract is prepared on a firm price basis in terms of the Standard Building Contract With Quantities for use in Scotland 2011 Edition (SBC/Q/Scot 2011) issued by the Scottish Building Contract Committee and the Contractor has undertaken to complete the works by 16 August 2013.

4 COMMUNITY BENEFITS IN PROCUREMENT (CBIP)

- 4.1 This proposed project has been allocated a requirement to achieve a minimum of 13 Community Benefit Points commensurate with the project nature, value and duration.
- 4.2 Messrs Hadden Construction Ltd have submitted with their Tender the following Community Benefits proposals:

CB1 Host a minimum of three school visits.

The above will provide 15 Community Benefit Points which satisfy this requirement.
