SUBJECT: CON-13-006 Design, Supply and Application of Surface

Dressing Materials 2013 - 2015

#### 1 PURPOSE

1.1 To inform Cabinet of the steps taken to procure the above Transportation Road Network Contract and provide details of the proposed work.

### 2 RECOMMENDATIONS

2.1 To note the decision of the Executive Director (Services for Communities) per the Head of Infrastructure, as appointed representative under Standing Order Rule 46 and delegation Appendix 2a (Tenders) thereto, and in conjunction with the Head of Council Resources, to award the contract for 2012/15 to Kiely Brothers Ltd subject to the acceptance of the necessary contract documentation and completion of the statutory procedures.

## 3 BACKGROUND

- 3.1 The winning tender will be utilised by East Lothian for the provision of Design, Supply and Application of Surface Dressing Materials over the next three financial years with an optional 2 year extension.
- 3.2 An advert was placed on Public Contracts Scotland on 8 February 2013 with a return date of 28 February 2013.
- 3.3 In accordance with the Council's Corporate Procurement Policies and Procedures tenders were subsequently issued, returned and assessed to determine the most suitably experienced Contractor giving due regard to quality and price, The price element was evaluated using the contractor submitted schedule of prices and predetermined model of quantities based on quantities used over the duration of the previous contract.

3.4 Only two companies noted interest in this tender, Kiely Brothers Ltd and Colas Ltd. Colas Ltd did not return a completed tender, therefore Kiely Brothers Ltd was the only completed tender received.

The tender rates supplied by Kiely Brothers Ltd have been fully analysed and compared to the previous financial year's surface dressing contract and represent value for money.

The evaluated tender score is indicated below: -

### 3.5 The proposed works Include:

Design, Supply and Application of Surface Dressing Materials at various locations throughout East Lothian for the next three financial years with the option to extend for a further two years.

2013/14 Locations are detailed in Appendix 1.

4.1 Due to the short duration of the Surface Dressing programme (2-3 weeks) and the specialist nature of the works community benefits have not been included within this contract.
