3 BACKGROUND

- 3.1 Neil Chatham will be competing in the International Six Days Enduro (ISDE) event in Sardinia, Italy, from 30 September to 5 October 2013, having been selected by the Scottish Auto Cycling Union for the three man Scottish team. This is the 88th ISDE and it marks 100 years since the motorcycling equivalent to the Olympics was first run as the ISDT in Wales in 1913. The Scottish team remains unchanged from the last event in Finland in 2011 when they finished as 9th Club team, one of the best results for a Scottish team in recent years.
- 3.2 Murdo and Ross Lunn have recently been participating in the JKA European Junior Karate Championships which were held in Krusevac, Serbia on 25 and 16 May 2013 as members of the ten strong JKA Scotland team.
