Footway Slurry Surfacing

### 1 PURPOSE

1.1 To inform members of the steps taken to procure the above Transportation – Road Network contract work and provide details of the proposed work.

### 2 RECOMMENDATIONS

2.1 To note the decision of the Chief Executive as appointed representative under Standing Orders Appendix 2a (Tenders), after consultation with the Executive Director of Environment (per the Head of Transportation) and the Head of Finance, to award the quotation to Kiely Bros Ltd, 135 Cherrywood Road, Bordesley Green, Birmingham, B9 4XE and limit the spend to £50,000.

### 3 BACKGROUND

- 3.1 Slurry Surfacing applied to bituminous footways is a proprietary material widely used by Local Authorities throughout the country as a low cost preventative maintenance process that seals the footway surface against the ingress of water, prevents further deterioration of the footway surface and adds surface texture..
- 3.2 As the annual budget level for this type of work is less than £50,000 in accordance with the Corporate Procurement Policy three contractors were invited to tender using the quick quotation process on Public Contracts Scotland.
- 3.3 The returned written quotations were checked and evaluated as follows:

Footway slurry surfacing at locations in Musselburgh, Wallyford, Cockenzie, Longniddry, Tranent, Ormiston, Pencaitland, Haddington, East Linton, Gullane, North Berwick, Dunbar, West Barns and Innerwick.
