- Planning Application No. 13/00105/P: Change of use of agricultural land and part change of use of yard (class 4 use) for use as 2 individual permanent Gypsy Traveller pitches (3 caravans per pitch), alterations and part change of use of building in class 4 use to shower/toilet facility, siting of 2 utility units, formation of raised decking/hardstanding areas, erection of fencing and gates (part retrospective) at 8A West Garleton Holdings, Haddington (pages 1-12)

 Note this application was called off the Scheme of Delegation List by Councillors McMillan (1) and Trotter (2) for the following reasons: (1) Given the comments in the report "...given the absence of specific planning policy relating to the provision of gypsy/traveller sites in the development plan..." I would like the Committee and the Community to have an opportunity to explore the Council's strategy in relation to this issue and the identification of "...suitable locations for meeting the needs of Gypsies and Travellers..." and (2) to have this application discussed before the full Committee.
- 2. Planning Application No. 13/00499/P: Erection of 1 house, fencing and gate and formation of vehicular access and turning area at Land Adjacent to Post Office, Humbie (pages 13-28)

Note - this application was called off the Scheme of Delegation List by Councillor Trotter for the following reason: Because of the concern this application has raised locally this should be heard at Committee level.

3. Planning Application No. 13/00211/P: Erection of wind turbine and associated works at Queen Margaret University, Musselburgh (pages 29-40)

Note - this application was called off the Scheme of Delegation List by Councillor Williamson
