## **1 PURPOSE**

- 1.1 To advise Members of the steps taken to procure the above Transportation – Road Network Contract and provide details of the proposed work.

## **2 RECOMMENDATIONS**

- 2.1 That Members note the decision of the Head of Infrastructure to award the contract for Carriageway Slurry Surfacing Works to Colas Limited, Dysart Road, Grantham, Lincs, NG31 7LG in accordance with the revised Scheme of Delegation (Appendix 2 to Standing Orders) section 1.11 Financial Limits and Section 4.6(f) of the Scheme of Delegation.

## **2 BACKGROUND**

- 2.1 Carriageway Slurry Surfacing is applied to bituminous carriageways and is a proprietary material widely used by Local Authorities throughout the country as a low cost preventative maintenance process that seals the carriageway surface against the ingress of water, prevents further deterioration of the carriageway surface and adds surface texture.
- 2.2 As the annual budget level for this type of work is £50,000 in accordance with the Corporate Procurement Policy three contractors were invited to tender using the quick quotation process. The tender was published on Public Contracts Scotland on 31<sup>st</sup> May 2013 with a return date of 14<sup>th</sup> June 2013 at 12 noon.
- 2.3 Two contractors returned written quotations and were checked and evaluated as follows:

2.4 The works include:

Carrageway slurry surfacing at locations in Longniddry, Pencaitland, East Linton, Aberlady and Gullane.
