'Hotbox Repairs'

1 PURPOSE

1.1 To advise Members of the steps taken to procure the above Transportation – Road Network Contract and provide details of the proposed work.

2 RECOMMENDATIONS

2.1 That Members note the decision of the Head of Infrastructure to award the contract for Permanent Carriageway and Footway Patching 2013-14 to M&M Road Surfacing Ltd, 9A Bankhead Medway, Sighthill Industrial Estate, Edinburgh, EH11 4BY. In accordance with the revised Scheme of Delegation (Appendix 2 to Standing Orders) section 1.11 Financial Limits and Section 4.6(f) of the Scheme of Delegation.

2 BACKGROUND

- 2.1 Current practice to address carriageway patching and repairs is undertaken on a temporary basis by use of the Council's jetpatcher. This is an effective means to make safe road repairs on a temporary basis but does not provide a long term solution. Employing a system of permanent repairs will improve immediate and safety defects response times and assists with the defence of 3rd party claims for loss and damage. This system of working will enable a quick response, providing a permanent repair demonstrating best value.
- 2.2 An advert was placed on Public Contracts Scotland on 7th June 2013 with a return date of 21st June 2013 at 12 noon. Eight expressions of interest were received with seven contractors submitting a tender.

2.3 In accordance with the Council Corporate Procurement Policies and Procedures tenders were subsequently issued, returned and assessed to determine the most suitably experienced Contractor giving due regard to quality and price. The price element was evaluated using a predetermined financial assessment model for quantities based on a typical annual works programme. The quality assessment was based on a pass/fail principle, which resulted in one tenderer being removed from the process. The remaining returned written tenders were checked and evaluated as follows:
