## **1 PURPOSE**

- 1.1 To advise Members of the findings of the Care Inspectorate regarding Tyneholm Stables Care Home

## **2 RECOMMENDATIONS**

- 2.1 Members should note the findings of the Care Inspectorate and the actions being put in place to address these.

## **3 BACKGROUND**

- 3.1 Tyneholm Stables Care Home received a grading of “unsatisfactory” across all areas on 24<sup>th</sup> January 2014. The Care Inspectorate imposed an improvement notice on the care home.
- 3.2 East Lothian Council suspended new admissions to the care home and led joint work with partners to improve standards and monitor progress.
- 3.3 The Care Inspectorate inspected the home again on 5<sup>th</sup> May 2014 and two areas were rated “weak” and two “unsatisfactory”.
- 3.4 This represented an improvement since January, but there is still significant work to do. The Care Inspectorate has extended the timescale for the improvement notice originally issued on 13<sup>th</sup> February 2014.
- 3.5 East Lothian Council has chaired several meetings for relatives of residents which have also been attended by the Care Inspectorate and the care home owners (European Care).
- 3.6 New admissions to the care home have not yet been agreed and further improvement will be required before this can take place.
