SUBJECT: Non-Voting Membership of East Lothian Health and Social Care Partnership Shadow Board

1 PURPOSE

1.1 To advise Members of the extension of the period of membership of the nonvoting members of the East Lothian Health and Social Care Partnership Shadow Board.

2 **RECOMMENDATIONS**

2.1 Members should note the extension of the period of membership.

3 BACKGROUND

- 3.1 It was reported to The Council on 25th February 2014 that five non-voting members had been appointed to the East Lothian Health and Social Care Partnership Shadow Board. These appointments were made for a period of six months initially.
- 3.2 The non voting members attended their first meeting on 22nd January 2014.
- 3.3 The appointments are:
 - 3rd Sector Eliot Stark
 - Carers Margaret McKay
 - Independent Sector Maureen Allan
 - Service User Keith Maloney
 - NHS Professional Alastair Clubb
- 3.4 It had been anticipated that progress with the legislation and guidance on integration would clarify the position on non-voting membership within six months from January 2014.

- 3.5 It is now clear that final guidance will not be issued until late 2014 following the current period of consultation.
- 3.6 The Shadow Board agreed at its meeting on 5th June 2014 to extend the current non-voting membership period to the end of March 2015.
- 3.7 It is currently anticipated that the Integration Joint Board which will replace the Shadow Board will be established in April 2015 and that there will be separate process to appoint non-voting members to the new Board.
