SUBJECT: Adult Wellbeing – Payments to Third Sector Agencies

1 PURPOSE

1.1 To seek Members' approval to make payments to third sector agencies.

2 RECOMMENDATIONS

- 2.1 Members are asked to:-
 - (i) Agree to award annual payments, for 2014-2015, as shown in Appendix A of this report. This funding can be met from within the approved budget for Adult Wellbeing
 - (ii) Note that in order to assist supported organisations cash flow arrangements, the quarter 1 payments have already been made. This payment covered the period from April 1st 2014 to June 30th 2014.

3 BACKGROUND

- 3.1 Partnership working with the third sector is central to the achievement of positive outcomes in adult social care in East Lothian. On-going investment provided through Section 10 grants has been used to support the delivery of these outcomes and a total of 36 agencies are now funded through the budget.
- 3.2 A strategic review of the Section 10 grants has been undertaken over the last couple of years to ensure that the needs of individual service users and community groups in East Lothian are supported on a best value basis. The outcome of the strategic review has identified a number of areas where savings can be identified on the basis that a service agreement is not currently in place which has clearly defined outcomes. In such cases, it is therefore recommended that funding is discontinued and details of those and other organisations affected are set out in Appendix A. Discussions have already

- taken place with these respective organisations, around the related funding implications.
- 3.3 For those organisations who continue to receive support, it is recommended that the level of funding continues to be made in line with 2013-14 awards.

4 POLICY IMPLICATIONS

4.1 There are no immediate policy implications arising from this report. Developing more robust commissioning and procurement arrangements for some of the services currently funded through grants, as recommended, will improve governance arrangements and will help to achieve both Best Value and desired service outcomes.

5 EQUALITIES IMPACT ASSESSMENT

5.1 As part of the strategic review process, equalities impact has been assessed as far as is practicable.

6 RESOURCE IMPLICATIONS

Financial - This report proposes payments to third sector organisations for 2014/2015, at a total cost of £1,358,914. This can be met from within the approved budget within Adult Wellbeing 2014-15, with the proposed savings to contribute in part to the delivery of the agreed efficiency savings with the Voluntary Organisation sector.
