1. Planning Application No. 14/000416/P: Change of use of office building and grounds to crematorium use with 1 groundkeeper's flat and associated operations at Alderston House, Haddington (pages 1 - 10)

Note - this application was called off the Scheme of Delegation List by Councillor Trotter for the following reason: I have called this application in for discussion before full committee and public due to the impact it would have on its neighbours and surrounding area.

This application was also called off the list by Councillor McMillan for the following reason: Local residents, neighbours and businesses in the area have raised legal, practical and economic concerns about the change of use to this historic building and how the site will be affected in terms of pollution and environment.  Planning Application No. 14/00319/P: Erection of fencing and heightening of wall (part retrospective) at 6 Winton Terrace, New Winton, Tranent (pages 29 - 34)

Note - this application was called off the Scheme of Delegation List by Councillor Grant for the following reason: the residents of 7 Winton Terrace, New Winton, feel their objections to this application have not been properly addressed in the Planning Officer's report and would like to address the Committee to voice their concerns.
