# 1. Minutes of the previous meeting:

The minutes were agreed as a true record

#### 2. Over provision

The forum expressed concerns at the previous meeting and wanted an explanation on why every application has been granted since the introduction of the act. Member states 'out of caution in every decision' Previous applications have all met the criteria, as on sales premise are decreasing it is becoming easier to grant new licenses. All new supermarkets will be subject to the over provision act. Haddington and Prestopnans will be among these.

Chair George Hood read from the over provisions act (taken as read) requesting further explanation on the word used exceptional.

Anwser was the Board is no longer unanimous as it was previously. The board is getting closer to making a refusal but haven't made it yet.

Member asked 'what would happen if you refused a supermarket, do you think you would be taken to court?'

From a police stand point we think the off-sale in haddington should of been blocked. However if a premises meet the 5 licensing objectives are understanding is it will be granted.

Jim Goodfella mentioned the work from QMU on the health statistics. The health statistics are OOD each area should be broken down and not only be related to hospital admittance but other alcohol instances including health anti-social behaviour.

Rickie Ross states' they are not getting in pubs and clubs the problems are coming from the offlicenses and supermarkets. Canada have shops which are specific for purpose. Perhaps this is a decision that needs to be made and looked at more closely.

John Thayers 'government releases SALSAS survey from ages 13+ these gives us an individual profile for each area, this shows changing behaviour in 13-15 year olds now drinking and taking drugs less. Under ages pre-dominatingly obtain alcohol from family and friends a The number of license premises has a direct approach on use. (taken as read from SALSAS survey) report seems conclusive

Drink drive limit best advise don't offer any advice to customers the message is don't drink and drive. Forum member noted a great scheme where designated drivers are offered free soft drinks which could be implemented in local pubs.

Kirsten Baired from QMUSU expressed her concerns over students over students being out until 3 or 4 am and still being under the influence of alcohol the next again day.

Jim Goodfellow asked whether or the matriculations card could be standardised so that all university's cards can be easily identified. Stated by member from QMU that this is being looked at.

# Doctors and alcohol campaigners support lower drink drive limit

Alcohol Focus Scotland, the BMA and SHAAP are urging drivers to avoid alcohol completely, as the new lower limit comes into force. We are also warning drivers to think carefully about getting in the car the morning after a night's drinking as they may still be over the limit. The reduction brings Scotland

into line with most European countries and is expected to prevent deaths and reduce the number of lives ruined by drinking drivers.

### Alcohol consumption and harm down but more to be done

NHS Health Scotland has published the latest <u>update report</u> on Scotland's alcohol strategy which shows a continued downward trend in consumption, alcohol-related deaths and hospitalisations. The new Health Secretary Shona Robison said: "It is encouraging to see a downward trend in alcohol-related harm, however the fact remains that almost 700 people per week are admitted to hospital in Scotland due to alcohol, which is why we are absolutely committed to introducing minimum unit pricing."

# Scottish Schools Adolescent Lifestyle and Substance Use Survey (SALSUS) 2013

#### Key alcohol findings:

- The proportion of 13 and 15 year olds who reported drinking alcohol in the last week was the lowest since the SALSUS began in 1990 (4% of 13 year olds and 19% of 15 year olds).
- 68% of 13 year olds and 30% of 15 year olds have never had an alcoholic drink.
- Of those who had ever had an alcoholic drink, 44% of 13 year olds and 70% of 15 year olds had been drunk at least once.

ISD provide a national overview, topic reports and local summaries for each local authority, ADP and NHS Board.

### Relationship between alcohol outlet availability and harm

Alcohol Focus Scotland recently commissioned <a href="CRESH">CRESH</a> to investigate whether alcohol-related illnesses and deaths across Scotland were related to the local availability of alcohol outlets. The research showed that across Scotland, alcohol-related hospitalisations and deaths were higher in areas with higher alcohol outlet availability.

The researchers also examined the relationship between alcohol outlet availability and harm at local level. The first 3 of these local authority factsheets, for Edinburgh, Glasgow and North Ayrshire, are now available. Read more

#### Alcohol and breast cancer campaign

Balance the North East Alcohol Office and Breakthrough Breast Cancer have joined forces to raise awareness of the link between alcohol and breast cancer. Alcohol is linked to thousands of breast cancer cases each year across the UK but many women don't re-plise that the

#### Call for review of law on sales to drunk customers

Anew report by Acohol Research UK and the Acohol Academy calls for a full review of the current legislation. Sales to drunk customers appear to be the norm, but annual prosecutions for the offence are rarely more than single figures. With very limited enforcement or awareness of the legislation, this report explores what needs to be done to address one of the most underenforced laws on the statute book.

#### Foetal alcohol syndrome case dismissed by Court of Appeal

Achild born with foetal alcohol syndrome is not legally entitled to compensation after her mother drank excessively while pregnant, the Court of Appeal has ruled. Lawyers argued her mother had poisoned her foetus but appeal judges ruled she had not committed a criminal offence. The case was brought by a Council in the North of England.

The seven year Rethink Good Health programme will support a variety of projects, with flagship work taking place in Glasgow, Sheffield, Devon, South Wales and Northern Ireland. Read more

#### Daily attacks on Scottish ambulance staff

Attacks on Scottish ambulance staff have soared by nearly 50% in the past five years, reaching an average of almost one a day. Workers were subjected to 321 assaults in 2013, with many of the attacks being fuelled by alcohol. Read more



### Alcohol-free beer grows in popularity

Non-alcoholic and low alcohol beer is on track to rise in global value by 26% from 2013 to 2018, the largest growth of any sector in the beer industry, according to Euromonitor. In Spain, 60% of beer drinkers are choosing alcohol-free versions, while Euromonitor notes that in Germany and Austria, "the appreciation of a beer's taste is taking precedence over the intoxicating effects of the tipple." #### Public support for health warnings on alcohol labels

Alcohol Focus Scotland has joined campaigners across the UK in calling for government action to introduce better labelling of alcoholic drinks. Under EU legislation, food and soft drinks packaging must show ingredients and nutritional information but alcohol is currently exempt from the regulations.

Research from the Alcohol Health Alliance UK (AHA) has shown that the majority of the British public support more nutritional and health information on alcohol product labels, as well as a warning not to drink when pregnant. The UK-wide survey found:

- 83% of people support information on how alcohol can impact on health
- 87% support a warning that when pregnant, the safest option is to avoid alcohol completely.

# Alcohol sales linked with alcohol deaths across GB regions

For the first time alcohol sales data (a more accurate and objective measure of consumption than self-reporting) and alcohol-related deaths for regions in Great Britain have been analysed. The results, published in the open access journal <a href="BMC Public Health">BMC Public Health</a>, show that of eleven regions analysed, Central Scotland had the highest alcohol sales per adult and also the highest alcohol-related death rate. Central Scotland had substantially higher spirits sales than any other region, especially through off-licences.

#### Glasgow tops list of alcoholics on benefits in the UK

Glasgow has twice as many people out of work because of alcohol problems than anywhere else. Figures from the Department of Work and Pensions show a total of 2,280 claimants in Glasgow are classed disabled due to their drinking. Three of the worst 10 council areas are in Scotland, with Edinburgh fifth and North Lanarkshire seventh. AFS said more needs to be done to help people into successful treatment as well as prevent problems from developing in the first place through policies like minimum pricing. Read more

#### First Minister determined to introduce minimum pricing

Writing in the **Evening Times**, First Mnister Nicola Sturgeon said:

"Although recent figures show a slight drop in the number of adults drinking at harmful levels, the fact is the numbers are still far too high. That is why we are taking strong action to help everyone to drink less - as well as targeting those most at risk. It is no coincidence that as affordability has increased, alcohol-related hospital admissions have risen. That is exactly why I and the Scottish Government are so determined to introduce a minimum unit price for alcohol."



## Lower drink drive limit sees 19% reduction in offenders

Scotland's new lower drink drive limit led to a 19% reduction in the number of

offenders caught over the festive period. Figures show 351 drivers - compared to 434 last year - were detected while under the influence. The lower limit is also having an impact on pubs, with Belhaven owner Greene King reporting slower than expected trading over the festive period. Paul Waterson, chief executive of the Scottish Licensed Trade Association predicted it will have a "bigger effect on the trade than the introduction of the smoking ban."

#### Beckham whisky ad cleared by watchdog

David Beckham's TV ad for whisky brand Haig Club has been cleared by the Advertising Standards Authority (ASA), despite complaints that his endorsement sent a confusing message about drinking to children. As a global youth icon who spent most of his football career teetotal,



Beckham's appearance in the ad promoted a critical response from Acohol Concern who called for the ad to be banned because it appealed to under 18s and implied drinking was linked to social success. Although David Beckham supports Sainsbury's Active Kids campaign, the ASAruled that Beckham is too old to be popular enough with children to warrant banning the ad. Read more

# Licences revoked for failure to complete Refresher training

Licensing Boards are beginning to revoke the licences of hundreds of personal licence holders (PLHs) across Scotland for failure to complete mandatory Refresher training within the required timescale of 5 years. It remains to be seen whether this will lead to the closure of any premises. There has been significant publicity about the first group of personal licence holders reaching the 'five year mark', but it should be remembered that there will consistently be PLHs requiring to complete Refresher training.
