1 PURPOSE

1.1 To present petition PET1504 to the Petitions Committee for consideration. This petition calls on East Lothian Council to revert back to its old timetable and route for the Bus service 120 - Dunbar to North Berwick. Changes were implemented to Bus Service 120 on 5 May 2015.

3 BACKGROUND

- 3.1 A paper-based petition was submitted by Mr M Fidgeon, on behalf of residents from North Berwick and outlying districts, in May 2015. The petition was deemed to be competent and has 237 signatories in support of the petition.

	 The former route of 120 service included access to both ends of the High Street, North Berwick. The new route makes it difficult for elderly people to access shops and services to the east of the High Street, in particular the Post Office and Library. The bus stop at Quality Street allowed easy access to the public toilets at the east end of the High Street – there are no public toilets near Church Street or the railway station. The centre of North Berwick can get very congested; having four buses stopping at Church Street will cause more traffic jams in Forth Street and the High Street.
