### 1. MINUTES FOR APPROVAL

The minutes of the Licensing Board meeting of 28 April 2016 were agreed to be a true record.

### 2. PROVISIONAL PREMISES LICENCE

### (a) North News, 179 North High Street, Musselburgh

Mr Alastair Macdonald, Macdonald Licensing, was present to represent the applicant. He advised that his client had been held up and asked that this matter be delayed until later on the agenda.

The Board agreed to take this matter later.

### (b) Sainsburys Store, Gateside West, Haddington

Ms Kevin Clancy, Shepherd and Wedderburn, was present to represent the applicant.

Mr Martin Wolfe, Store Manager was also present.

The Clerk advised that a Provisional Premises Licence had been granted for this store in March 2012 but had expired in March 2016. This was an application for a further Provisional Licence in the same terms.

Mr Clancy addressed the Board advising that the economic conditions since 2012 had led to a delay in progressing with this store. Sainsbury were undertaking a review of their estate and still saw an opportunity to progress with a store in Haddington although the granting, or not, of this Provisional Licence would have an impact on their plans. He directed the Board to the statement on the Licensing Objectives that accompanied the application and supported his assertion that this application would not contravene the Board's policy on overprovision. In particular, he noted that there were no other licensed premises within 500m of this site. As housing development is progressing on an adjacent site, he argued that the granting of a licence for a future store here would meet a need that is currently not being met by any other licensed premises.

He answered questions relating to the future plans for the site and was advised that Members were frustrated at the lack of progress in this regard.

Insp Harborow and the Licensing Standards Officer (LSO) had nothing to add to their written reports.

### **Decision**

East Lothian Licensing Board agreed to grant this application.

### (a) North News, 179 North High Street, Musselburgh

Mr Alastair Macdonald, Macdonald Licensing, was present to represent the applicant.

Mr Zohaib Mailik, applicant, was also present.

The Clerk advised that a public objection had been received along with three letters of support. Neither the objector nor the supporters were present. The Clerk advised that the letter of objection appeared to be referring to another premises, next door to the actual premises that are the subject of this application.

Mr Macdonald addressed the Board on this client's plans for this shop, noting that it was a very small shop meeting a local need for small scale groceries. His client had asked customers what they would like to see stocked and there was a demand for a small stock of alcoholic drinks. Mr Macdonald was of the view that the immediate vicinity of this shop was not over provided with licensed outlets; the only other off sales premises was the Day to Day shop near the Brunton hall. Larger supermarkets at Tesco and Lidl were not within easy walking distance, particularly for elderly customers.

With regard to the letter of objection, Mr Macdonald's client had owned the premises since November 2015 and had not seen any behaviour of the type set out in this letter. He clarified that the music referred to would be background music or the radio only.

The Licensing Standards Officer (LSO) advised that this was a very small shop and would have a very small licensed area if granted. During the time he had visisted the shop, he had noted the high number of local customers using it and wouldn't see the grant of a licence compromising the Licensing Objectives. He would support the grant of this licence.

Insp Harborow stated that this area of Musselburgh had historic problems of anti social behaviour. It was an objective of the CAP to deal with this and he considered that the grant of a new off sales licence in this area would be to the detriment of the work that was ongoing in this regard. He reminded Members that the Board's Overprovision Statement required there to be 'exceptional circumstances' before a new licence would be granted.

Under questioning from the Members, Insp Harborow agreed that these premises were not responsible for any of the previous anti social behaviour.

Councillor McAllister agreed with the Police's views of the historic problems in this vicinity and was of the view that alcohol was a significant factor in this. Whilst he accepted that this premises hadn't contributed to problems previously, he was not satisfied that 'exceptional circumstances' had been demonstrated and could not support this application. He considered that a grant of this licence would compromise the Licensing Objectives relating to crime and disorder, public safety and the protection of children and young people.

Councillor Currie considered that the number of takeaway shops in this area, along with the availability of off sales, could contribute to an increase in anti social behaviour. This would be regrettable given that matters seemed to have improved over recent years as a number of licensed premises had closed. On balance he considered that the grant of this licence would have a negative effect rather than a positive effect and so he could not support this application.

Councillor Innes noted that the LSO was supportive of this application as it would meet a local need. In addition, three local residents had written to the Board to support the applicant. He considered that the shop was very small and it was unreasonable to consider that this modest size of licensed premises would have a significant impact on anti social behaviour in the vicinity. He supported the application.

Councillor Akhtar also supported the application. She considered that the level of information provided by the applicant relating to compliance with the Licensing Objectives was very impressive for a small community retailer and was satisfied that the applicant would act in a responsible manner.

Councillor Grant understood the caution in this matter but noted that there is no blame attached to these premises or this applicant for historic issues in the area. He did not think this licence would constitute a significant risk and was minded to grant it, noting that, if problems arose, the Board had the powers to deal with these.

The Board voted on this matter as follows:

For: 3 Against: 2 Abstention: 1

**Decision:** Accordingly, East Lothian Licensing Board agreed to grant the application.

### 3. VARIATION TO PREMISES LICENCE

### (b) Giancarlo's, 119 High Street, Tranent

Mr Alastair Macdonald, Macdonald Licensing, was present to represent the applicant.

The Clerk advised that the application seeks to vary the operating plan to allow outside drinking as an activity and amend the layout plan to show the outside area as part of the licensed premises.

Mr Macdonald advised that this business had been extremely popular and successful and his clients were simply wishing to extend their offering to allow some outside dining space. They had a permit from the Council's transportation department that allowed use of the pavement until 2100 hours. He noted the Police request that use be limited to 2200 hours and suggested an amendment to the Operating Plan to show the time limit as 2200 hours or as restricted by the permit as he hoped that his clients could vary the permit to allow a terminal hour of 2200 hours.

Members asked questions about the music in the premises and Mr Macdonald advised that his client would accept a condition that there would be no music in the outdoor area. The transportation permit already prohibited amplified music and speech in this area.

Insp Harborow and the Licensing Standards Officer (LSO) had nothing to add to their written reports.

The Board agreed to grant this application, subject to the amendment to the Operating Plan regarding the terminal hour and a condition prohibiting music in the outdoor area.

### 4. OCCASIONAL LICENCE

### (a) Macmerry Miners' Welfare Society and Social Club.

Mr James Fortune, President and Mrs Jessie Young, Vice President were present on behalf of the Macmerry Miners' Welfare Society and Social Club.

The Clerk advised that this was an Occasional Licence application but that, as objections had been received from Police Scotland and from the LSO, it had to be considered by the Board. The Occasional Licence sought was for the period from today to 8<sup>th</sup> June and was in respect of the premises adjacent to Macmerry Bowling Green.

Mr Fortune advised that the Club were in the process of applying for a Premises Licence for these premises but wished to get the bowling section up and running while this application was pending. Accordingly, they had applied for this Occasional Licence.

The Licensing Standards Officer confirmed that there had been contact with the Licensing Team regarding an application for a Premises Licence. His concern was that this application was for a non-specific purpose, ie not a particular event.

Insp Harborow did not wish to add anything to the terms of his letter of 16<sup>th</sup> May.

Councillor Grant noted that there was a long history here but that was all outwith the Board's remit. He was pleased to note that an application was forthcoming for a Premises Licence and would support this application for an Occasional Licence. Councillor Akhtar agreed as did Councillor Currie.

Councillor Innes noted that, should further Occasional Licences be required to bridge the gap while the Premises Licence was being processed, he would look favourably on these.

The Clerk confirmed that, at present, this was the only application before the Board. It was likely that the Premises Licence application would not be before the Board before the August meeting at the earliest.

### **Decision**

East Lothian Licensing Board agreed to grant this application.

### 5. REVIEW OF PERSONAL LICENCE

### (a) Ryan Baynham

Mr Macdonald, Macdonald Licensing was present to represent Mr Baynham.

Mr Baynham, personal licence holder, was also present.

The Clerk advised that Police Scotland has requested a review of Mr Baynham's personal licence and that the Board had agreed to continue the item from the April 2016 meeting.

Mr Macdonald advised the Board that the Procurator Fiscal had not yet decided whether or not to take proceedings in respect of this matter. Pending that decision, he felt he might not be able to be totally open with the Board but was prepared to proceed today if that was the wish of the Board. Alternatively, he would be happy to have this matter continued pending the decision on court proceedings.

Insp Harborow advised that he was equally happy to leave this decision to the Board. However, if the matter was to be continued, he would propose to monitor the progress of the court proceedings and, if there was undue delay, would be asking for the matter to be dealt with by the Board.

### **Decision**

East Lothian Licensing Board agreed to continue the review of the personal licence until their meeting in August 2016 in the first instance to determine whether a decision had been made by the Procurator Fiscal at that time.



It has come to our attention that the Elphinstone Miners Social Club is applying for an open licence.

We are the in the village of Elphinstone, we wish to make clear our objections to any attempt to extend the licence of the said club.

The miners Social Club is sited on the farm entrance road which is a private road. This road has been maintained by ourselves for the last forty years. The club was originally used by local miners and their families when there was an active coal mining industry in the area, at that time very few people had cars and locals walked to the club and a pedestrian right of access was attained. Over the years as time have changed the club has had to rely on visitors from out with the village to keep it open. This has resulted in cars arriving and blocking the farm road, as patrons cannot, or do not try to find a proper place to park. We have put up signs stating that the road requires access at all times but they are ineffectual most of the time.

We are not only a working farm with land on either side of the village, with large machinery working long hours in need of twenty four hour access. We are also a family requiring access to and from our home at all times of the day and night; it is not unreasonable to insist that the social club prevents their patrons from blocking our driveway.

An unfortunate change in management recently has resulted in an escalation of incidents involving patrons and members of the club and the disgustingly aggressive behavior of member/patrons has resulted in the police being contacted at least once a week at present. It is now almost impossible to enter the club to ask members to unblock our driveway. We have no point of contact in authority to notify about the problems the club is causing and they have failed to provide us with any assistance. The lack of notification of this change in the licence is typical of the disrespect we and our property receive.

The club has a car park; it is poorly maintained and ironically has been locked to prevent local residents from using it. The club has failed to indicate its presence and although we have had

assurances from East Lothian council to signpost its existence, none have materialised. The police have advised the club to open their car park and we have noticed the barrier raised of late.

The farm entrance is on a bend in the road next to a major junction in the village. This limits the ability for road side parking. The residents in the village try to park outside their homes at night and at weekends and of course there are more vehicles than ever as this is a village with few facilities and limited public transport. The club is organizing events in the evenings and weekends when there is little or no road side parking available, and so it is easier for patrons to bloke our entrance than find a legitimate parking space. An open licence would make an already impossible situation even worse.

We have had to put a gate at the bottom of the farm road to prevent vehicles setting off our security alarms when turning in our yard late at night, the gate also prevents cars racing up and down the farm road. We maintain the road and grass verges to a high standard only to have the grass constantly damaged by vehicles trying to turn on a narrow drive rather than reverse back:

Taxis are also a constant problem as they park in the middle of our drive and their drivers usually wait inside the club for their fares to decide to leave. This is particularly difficult for female members of our family returning home and very uncomfortable about entering the club at closing time with many of the patrons having been drinking.

We have had assurances in the past by the club of efforts to keep our entrance and driveway open but they have always fallen on stoney ground sooner or later.


We have written to the Coal Authority Social Welfare Committee but they have only put a solution in the hands of the Club. We have had lawyers write to them also.

We have contacted the police, who have been very helpful and sympathetic and will continue to help us but their priority must go to other offences.

We have contacted East Lothian council about signs and road markings.

We have even contacted the council Licencing authority in the past.

Surely it is not right that a family and small business should be treated with the contempt we have to endure and the granting of an open licence would result in an escalation of unacceptable incidents. As a club all visitors should be signed in and are therefore accountable to the club for their actions, it would be possible for the club to transfer blame to people out with their responsibility if they gain an open licence. The very existence of this club must surely be questioned if they fail to act reasonably within the community.





Dear Ms MacNeill

I wish to object to the application for major variation at the Elphinstone Minors Welfare and Social

I received a letter informing me of the plans to vary the premises license on the 26<sup>th</sup> April 2016 and that I have the opportunity to object.

Over the last few months I have experienced threatening and anti-social behaviour on numerous occasions from people using the Social Club. I fully believe that the variation in license will only worsen these problems.

There has been criminal damage caused to property belonging to the involved cars screwing up grass and driving over decorative stones which were put into place to stop cars turning on the grass as it happens that often. I approached one man doing this recently and experienced threatening behaviour. In addition to this damage, there have been cars parked on the private farm road every day belonging to people using the Social Club. This continues to be an ongoing problem despite signs stating the farm road must be clear 24 hours a day as it is a working farm.

was blocked in due to a car parked on the road and when he went into the club to ask for it to be removed he was threatened by numerous men younger than him. Later that day, were also threatened as we stood in my garden by two separate men on the private farm road. These incidents were all reported to the police and between my we have had diary appointments with various police officers to discuss these issues. In addition, I have witnesses to these events and also photographic evidence of vehicles parked on the private farm road, outside my home which is opposite the Social Club, and of the damage caused by cars turning on the grass.

There is also an ongoing problem with glasses and bottles being taken from the club and being smashed on the farm road and thrown into the farm cottage gardens. Litter in the area is also a constant problem.

In addition to these problems, I am also regularly woken up at around 1:30am to 2:00am on Saturday and Sunday mornings by drunk and disorderly people leaving the club. I have to listen to drunk shouting and singing, and frequently there are fights that spill out onto the farm road, approximately 10 meters from by bedroom window.

Another issue is that during the evenings or weekends, I enjoy sitting in my front garden but I feel too uncomfortable to do so as I frequently have people smoking on the front lawn of the Minors' Club watching over me with the smell of cigarette smoke in the air less than 10 meters from my


garden. As far as I am aware, this is not a designated smoking area as these smokers are simply standing outside an emergency exit.

These problems have been ongoing for many years now but I believe the club management has changed personnel since the beginning of the year and my family and I have noticed a dramatic increase in the occurrence of these incidents since these changes. As I mentioned before, the police have been contacted on numerous occasions but there have been no improvements. The club has its own car park but fails to open the gates regularly or notify its users that there even is a car park or where it is, by either word of mouth or by putting up signs.

I wholeheartedly believe that the management is incapable of running the club to an acceptable standard and if the application for license variation is granted, these problems will become much worse and much more frequent.



I am responding to letters from the Licensing Board dated 16th May, 20th May and email dated 1st of June all 2016.

### 16th May

- 1) At no time has the road been blocked as it is a 2 lane road and conventional vehicles from the farm have never been impeded. During harvest when large vehicles pass up from the farm no vehicles park in the road. The signage at the entrance to the road is poor and requires to be upgraded. (See photographs) I would suggest that if access to the farm is so critical a locked barrier should be erected at the entrance to the road.
- 2) We can categorically confirm that no aggressive behaviour has taken place outside the Club. There have been no visits or communications from Police Scotland in this connection.
- 3) Following a visit by Police Scotland on the 10th April in connection with the parking problem it was agreed that the car park barrier would be permanently open. Historically the car park was closed as local residents were using it to park caravans and to carry-out business activities.
- 4) Members and visitors to the Club have never parked on the grass edges at the entrance to the farm. The farmer places cones across the road to prevent access to the grass verges.

### 20th May

- 1) We are not aware of any threatening or anti-social behaviour taking place. There have been no visits or communications from Police Scotland in this connection.
- 2) We are not aware of any criminal damage taking place. There have been no visits or communications from Police Scotland in this connection.
- 3) We can categorically confirm that there has never been a problem with broken glass outside the Club.
- 4) We are not aware of drunk and disorderly members and guests causing a problem on egress from the Club. There have been no visits or communications from Police Scotland in this connection.
- 5) We were not aware of a problem with smokers outside the Club. If members and guests are smoking outside a fire door we will ensure that this practice ceases.

### email 1st June

- 1) On Sunday 5th of June one of our Committee members had a party for her 7 year old granddaughter in the Club from 10.00am until 12.00 noon. A number of parents dropped their children off outside the Club and immediately reversed to the main road. Police Scotland were called.
- 2) These parents were visitors to the area and were not aware of the parking restrictions. Again as item 1 above the farm signage requires improvement.
- 3) For you information signs have been erected in the Club clearly stating that the road outside is a No Parking Area. Sample attached.

Additionally we have contacted ELC Roads Department and have instructed 3 Parking signs to be erected on the main road. Details of sign positions attached.

### **APPENDIX**

### **CAMERON SANGSTER ROSS**

About 1300 hours on Wednesday 10<sup>th</sup> June 2015, the applicant was in the company of two other males on the High Street in Musselburgh. One of the other males had cause to speak with a group of younger males in relation to an outstanding debt of £50 owe over the sale of a guitar. One of the younger males (a 17 year old) took his wallet out of his backpack and handed £50 to this male in payment for the guitar.

The younger group then walked away towards a vennel in Kilwinning Place. They were followed by the applicant and the other unknown male. Some of the younger males noticed the applicant removing the males wallet from his backpack. By the time the younger male noticed this the applicant had moved in front of him with the wallet in his hand he began to tease the male, swiping the wallet away from his reach a number of times, the applicant stating that the male was "owe interest". The younger male was unsure at this point if the applicant was joking or not.

The applicant removed a £20 note from the wallet, which he placed in his pocket before throwing the wallet onto the ground. The younger male kneeled down to pick the wallet up and as he stood back up the applicant punched him in the face. The young male was able to stand up however found this to be very painful and felt his tooth chipping on impact. The applicant thereafter walked away from the locus.

The younger male returned to Musselburgh Grammar School where the depute head teacher contacted police on his behalf.

About 1630 hours, same date, a statement was noted by police, from the younger male at his home address. Police noted that the male had significant swelling around his right eye and that his tooth had been chipped. Statements were also noted from the younger male's three friends, all of whom named the applicant as the male responsible for the theft and assault.

About 1730 hours on Thursday 11<sup>th</sup> June 2015, officers attended at the applicants home address where he was arrested and conveyed to Dalkeith Police Station. On route the applicant proceeded to justify his actions to the officers on the grounds that the younger male had been owe money to his friend.

About 1825 hours, same date, the applicant was cautioned and charged with a theft and assault and held in custody to appear at Edinburgh Sheriff Court the following morning.

On 25<sup>th</sup> September 2015, the applicant was found guilty of Theft and Assault to Injury, sentence was deferred until 21<sup>st</sup> March 2016 when he was Admonished.
