## 1 PURPOSE

1.1 To note the decision to award the contract for the Proposed Bathroom and Shower room Adaptations to Council Houses – Framework Agreement, to Messrs L & D Services Ltd.

### 2 RECOMMENDATIONS

2.1 Cabinet is asked to note the decision of the Head of Development in consultation with the Head of Council Resources and the Head of Communities and Partnerships to accept Messrs L&D Services Ltd's tendered rates and prices (See part 8 – Background Papers), for the Proposed Bathroom and Shower room Adaptations to Council Houses – Framework Agreement, for 1 year plus an option to extend for up to 1 year.

## 3 BACKGROUND

3.1 The Council is proposing to continue the ongoing programme of Bathroom and Shower Room Adaptations in Council houses. This contract will run for one year from the date of award plus any extension up to a further one year. This proposed contract replaces a framework contract between the Council and Keepmoat Ltd who previously provided this service after mini competition between the two contractors on the LHC Whole House Framework Lot available for Southern Scotland. This framework has now expired and offered the additional advantage of a members' rebate to the Council from the LHC. This contract with Keepmoat Ltd was terminated by mutual agreement in October 2016. A number of ongoing issues made a continuing relationship untenable.

After consultation with the Council's Corporate Procurement Department and the "not for profit" organisation, SPA (Scottish Procurement Alliance), it was agreed that the Council should make direct award of this contract to the 1nr available specialist in this area of work from the appropriate SPA framework lot, L&D Services

As an SPA Framework Contractor, L&D Services Ltd have been vetted and have demonstrated a track record in this kind of project. By using SPA to procure these services the Council is eligible to receive a members' rebate based on SPA's operating surplus at the end of the fiscal year.

Tender documents were issued to L&D Services to provide framework rates and prices for the Council's standard bathroom alteration types and a compliant priced schedule was received (See part 8 – Background Papers)

3.2 The table below illustrates a like-for-like comparison of rates and prices received from L&D Services Ltd and the rates and prices for which works were carried out under the previous Keepmoat Ltd contract. Note: The amounts shown are notional totals for works associated with a set of standard bathroom alterations, and are for the purposes of comparison only. These rates and prices form the basis of the total overall spend against this rolling programme of bathroom alterations. See Part 7 – Resource Implications, for reference to actual anticipated spend.

- 3.3 It will be noted that the rates and prices submitted by L&D Services represent improved value for money when compared to the previous agreement.
- 3.4 The Contract has been prepared in terms of the JCT Minor Works Building Contract for use in Scotland (2011 Edition) incorporating Amendment 1 (March 2015).
