Declarations of Interest:

Councillor Currie and Councillor Williamson declared an interest in Item 3 on the agenda as both had expressed a view on the applications prior to the meeting.

1. APPLICATIONS FOR GRANT OF A TAXI/PRIVATE HIRE CAR LICENCE

The Sub-Committee had received 2 applications; one was refused and one was continued.

2. SUSPENSION OF TAXI/PRIVATE HIRE CAR DRIVER'S LICENCE

Two licence holders had been invited to attend. The suspension was removed from one licence and continued to the date of expiry (December 2017) on the other.

3. APPLICATIONS FOR GRANT OF TEMPORARY PUBLIC ENTERTAINMENT LICENCE

The Sub-Committee had received two applications. One application was granted in part and the other application was granted in full.

4. APPLICATION FOR GRANT OF A WINDOW CLEANER'S LICENCE

The Sub-Committee had received one application and it was refused.
