1 PURPOSE

1.1 To note the decision to award the contract for the Proposed Internal Alterations & Window Replacement at Kings Meadow Primary School, Haddington to Messrs Bell Group Ltd, Kirkcaldy.

2 RECOMMENDATIONS

2.1 Cabinet is asked to note the decision of the Head of Infrastructure in consultation with the Head of Education and Head of Council Resources to accept Messrs Bell Group Ltd's tender amounting to £252,659.56 after checking, correction and savings, and noting that it is open for consideration until 12 September 2017 for the Proposed Internal Alterations & Window Replacement at Kings Meadow Primary School, Haddington.

3 BACKGROUND

3.1 A temporary Letham Primary School facility is required to accommodate the pupils arising from the early years of the housing development at Letham Mains, Haddington in advance of the new Letham Primary School completion in August 2018. The temporary facility will be located in Kings Meadow Primary School. In order to accommodate the Letham pupils, Kings Meadow Primary requires acoustic improvements to the existing accommodation. This will be carried out during the summer holidays 2017 along with Property Maintenance's programme of essential fabric repairs to windows, internal doors and wall finishes.

3.2 Tender Documents were issued to the five contractors listed on Lot 2 of the Council's Construction Framework via the Public Contract Scotland Quick Quotes facility. The following offers were duly received with the lowest three being subjected to detailed checks resulting in the Tender Amounts indicated below:

- 3.3 As indicated at 3.2 Messrs Bell Group Ltd's tender amounting to £256,959.56 after detailed checking and correction remains the lowest of the offers submitted and has been competitively priced throughout.
- 3.4 Messrs Bell Group Ltd have indicated that they proposed to use the following Sub-Contractors:

Wall Lining - J&M Interiors, Dundee

Flooring - Westend Flooring, Dundee

Moveable Partition - Style Scotland, Tillicoultry

3.5 The Contract is prepared on a firm price basis in terms of the JCT Minor Works Building Contract for Use in Scotland (2011 Edition) issued by the Scottish Building Contract Committee and the Contractor has undertaken to complete the works within 11 weeks from the date of commencement.

4 COMMUNITY BENEFITS IN PROCUREMENT (CBIP)

4.1 Messrs Bell Group Ltd have been made aware of the Council's CBIP requirements. The Council's Community Benefits Co-ordinator will contact the contractor to agree a suitable level of CBIP for this contract.

7 RESOURCE IMPLICATIONS

7.1 Financial – As a result of the lowest tender being in excess of the Council's budget allowance for this project a value engineering exercise was undertaken and savings have been identified. The savings have been achieved by omitting the provisional dayworks allowance contained in the tender sum. This omission will not affect the quality of the work.

After applying the savings the revised tender sum is as follows:

Together with the addition of Removal Costs the total project expenditure will not exceed £256,960.00 and has been approved by the Head of Council Resources.
