Discussion regarding the over provision policy within the licensing statement policy, the Forum feels that this policy is inadequate for its purpose. As a Forum we feel there is no Guidance on over provision and that the Scottish Government should treat this as a priority.

## 4. Licensing Standards Officer Report

Rudi Fruzynski reported:

Due to Local Elections there will be no Licencing board meetings held until 22 June 2017.

Amendments to the Alcohol Licensing/Air Weapons Law went live on the 15 May 2017; these changes can be found on East Lothian Licensing Forum website.

Rudi remarked that in trying to promote the East Lothian Licensing Forum by taking it out into the county to different locations over the last 12 months it has led to no added attendance.

Minimum pricing hearing will be held at the Court of Session on 17 July 2017 but decision will take 2 - 3 months to be published.
