1. TAXI FARE REVIEW

The Depute Chief Executive, Resources and People Services, had submitted a report for the Council, as Licensing Authority, to review the table of taxi fares.

Kirstie MacNeill, Legal Adviser, presented the report and advised the Sub-Committee that there was a statutory requirement for the Council to review taxi fares at least once every 18 months. The last review had taken place in November 2015, meaning that the next review had to be undertaken no later than May 2017.

To ensure that this timetable would be comfortably met, the Licensing Team would issue a consultation letter to the local Taxi Trade Association inviting proposals on the rate of taxi fares for the current review. The Council also had to advertise any new proposed scale of fares in the local press before they could come into force.

The Legal Adviser informed Members that the Chair of the East Lothian Taxi and Private Hire Association had been in contact with the Licensing Office to advise that the Association wished to proceed with a fare review.

Decision

The Sub-Committee agreed to commence a review of taxi fares.

SUMMARY OF PROCEEDINGS - EXEMPT INFORMATION
