SUBJECT: Access to Leisure Scheme

1 PURPOSE

1.1 The purpose of this report is to provide information on an adjustment to the Access to Leisure cost proposed by enjoyleisure and approved under delegated authority.

2 RECOMMENDATIONS

2.1 It is recommended that Councillors note the information provided on the Access to Leisure scheme and adjustment to cost.

3 BACKGROUND

- 3.1 The Access to Leisure Scheme offers residents of East Lothian who qualify through eligibility criteria to benefit from discounted rates to access Sport and Leisure provision within the County (see Appendix 1).
- 3.2 Having previously been known as Leisure Pass, the scheme was re-visited and amended to Access to Leisure in March 2013. A group reviewed the categories and cost of the scheme and benchmarked the East Lothian scheme with other similar schemes operating elsewhere across Scotland within Local Authorities and Leisure Trusts. An increase in price from 50p to £1 was approved as part of the review.
- 3.3 Within the approved Council budget for 2018/19, £150k was allocated for a reduction in the contract payment to enjoyleisure. As an efficiency measure, enjoyleisure have proposed an increase in cost of a single Access to Leisure use from £1 to £1.50. The proposed price increase aims to support the reduction in budget whilst continuing to offer discounted rates to access Sport and Leisure provision. There are no other changes to the scheme proposed other than the price increase.

3.4 Through delegated authority the Head of Infrastructure in consultation with the Cabinet Spokesperson has approved the increase in price. This change will take effect as of the date of this report.

4 POLICY IMPLICATIONS

4.1 This report supports the Council's commitment to equalities and promoting Community Wellbeing as there are no changes to the Access to Leisure scheme proposed other than an increase in cost. It contributes to promoting healthy communities and supporting disadvantaged individuals and families. It is consistent with the Council's priority of promoting healthy living and improving social care.

The Application Process

- Hand your completed application into a sports centre, community centre or The Brunton.
- This will be sent to the enjoyleisure Head Office for processing.
- For applications where the accompanying paperwork is complete, the aim is to process cards within 14 days of receipt.
- Cards should be collected from the place you nominated after 14 days.
- Cards are issued free. However, if they are lost or damaged, a £2 replacement cost will be charged.

In order to keep costs down, our preferred method for contacting you regarding your card will increasingly be by email or text. Your email address and mobile number will be used for Administrative purposes only. If you are happy to receive texts or emails for other communications from *enjoy*leisure, there is an "opt-in" tick box overleaf.

ACCESS TO LEISURE

What benefits do I get from the card?

The Access To Leisure card allows use of East Lothian Council's leisure facilities:

- from Monday to Friday
- between 9.00am and 4.45pm (latest booking 4.30pm)
- for £1 per session
- reduced rates operate at all other times.

To qualify, users must reside in East Lothian and meet one of the categories listed overleaf.

Access To Leisure Cards give entry to gyms, swimming pools, golf, crèches, fitness classes and children's sports programmes.
