LICENSING (SCOTLAND) ACT 2005 - SECTION 84A REPORT OF CONDUCT INCONSISTENT WITH LICENSING OBJECTIVES PERSONAL LICENCE HOLDER: ZOHAIB ZULFIQAR MALIK


The Chief Constable hereby reports to the Licensing Board in terms of Section 84A of the Licensing (Scotland) Act 2005 that Zohaib Malik, has acted in a manner which is inconsistent with the licensing objectives articulated at Section 4(1) of Act, namely:

- Preventing Crime and Disorder
- Securing Public Safety

Mr Malik is a Personal Licence Holder, granted by the Edinburgh Board on 8th November 2016. He is currently the Premises Licence Holder and Designated Premises Manager of North News, 179 North High Street, Musselburgh.

The following information is provided for the Board's consideration.

On Friday 11th May 2018 at 1903 hours two calls were received by the police regarding a male causing a disturbance at the Lowcost Supermarket, 119-121 North High Street, Musselburgh. On police arrival, officers spoke with Mr Malik, who was pointed out to them as being responsible.



The licensing officer was not made aware of this incident at the time and it has only come to light in the last couple of weeks.

Following the licensing officer being made aware of this incident some checks were carried out and a further call to the Mr Malik's own shop at 179 North High Street, Musselburgh was discovered. This time, it was a call from a concerned member of the public stating that she had entered the shop around 2100 hours on Wednesday 18th July 2018 to purchase something and there was nobody within the shop. The shutters were up and the door open but there were no members of staff within the premises. She went to get a friend who was nearby and they both

re-entered the shop, shouting for the shop keeper. Whilst within the shop, 3 males entered the store, looked around, then, stole alcohol and money from the till. A short time later the caller informed the police that the shop keeper had returned.

The following morning police made a call to the shop premises and spoke to a member of staff who stated that he had opened the shop this morning and the shop was in a mess and that there was money missing from the till along with other things. He stated that he had tried to get in touch with Mr Malik (his boss)

he had returned later that night and locked the shop up. He was aware that the police needed to speak to him about the theft of money which was eventually reported as being approx. £600.

The above two incidents are very concerning and not conduct which is expected of a Personal Licence Holder. There are serious concerns about the violence shown in the above incident and Mr Malik's threats to another and his overall ability to operate a licensed premises.

Whilst I appreciate that the first case is still 'pending' at court, it was felt that these two incidents be brought to the Board's attention, sooner rather than later, due to the concerns for the licensing objectives, namely preventing crime & disorder and securing public safety.

The Chief Constables view is that a revocation of Zohaib Malik's Personal Licence is appropriate in these circumstances.
