1 PURPOSE

1.1 To note the decision to award the contract for the Proposed Social Work Adaptations to 80Nr Council Houses (2020) at Various Addresses, East Lothian to Messrs L&D Plumbing & Tiling Services Ltd Glasgow

2 **RECOMMENDATIONS**

2.1 Cabinet is asked to note the decision of the Head of Infrastructure, in consultation with the Head of Development, to accept Messrs L&D Plumbing & Tiling Services Ltd's tender amounting to $\underline{\pounds417,188.67}$ after checking, and noting that it is open for consideration until 12th December 2020, for the Proposed Social Work Adaptations to 80Nr Council Houses (2020) at Various Addresses, East Lothian.

3 BACKGROUND

3.1 The Council is proposing to continue the ongoing programme of Social Work Adaptations, Bathroom and Shower room Adaptations in Council houses.

A Contractors Framework Agreement is in place to deal with the Councils programme of Bathroom and Shower room Adaptations, and the conditions of this framework allow the Council to run a mini competition inviting the framework contractors to submit competitive tenders for a defined scope of works. The Council has identified works involving the modernisation of 80Nr previously adapted bathrooms, and a tender package was prepared. The main purpose of this exercise is to gain the benefit of economies of scale through offering the successful contractor guaranteed volume. See part 3.4 below for further comment on this.

3.2 After consultation with the Council's Corporate Procurement Department, tender documents were issued to the Framework Contractors, and the following 2Nr offers were duly received.

- 3.3 As indicated at 3.2, Messrs L&D Plumbing & Tiling Services Ltd's tender amounting to £417,188.67 after checking and correction, is the lowest of the offers submitted, and has been consistently and competitively priced throughout.
- 3.4 A value for money assessment of the lowest tender has been carried out by the Council Quantity Surveyor. This involved comparing the tendered average cost per bathroom adaptation with the live framework rates for the same work from the same contractor. This exercise demonstrated that average adaptation costs contained in this tender are some 4% lower than the comparable live framework rates.
- 3.5 The Contract has been prepared in terms of the JCT Minor Works Building Contract for use in Scotland (2011 Edition) incorporating Amendment 1 (March 2015).

4 Community Benefits in Procurement (CBIP)

4.1 Messrs L&D Plumbing and Tiling Services Ltd have undertaken to comply with the contract requirement governing the Contractors Community Benefits responsibilities.
