	IC explained members felt that that application from Musselburgh	
	Grammar School (MGS) CDT department for equipment should be	
	provided by East Lothian Council. IC agreed to take this forward and	
	has spoken to applicant and Lesley Brown (LB) from Education	
	regarding this. LB explained that all schools were notified that the	
	educational attainment fund would no longer be held by Area	
	Partnerships. IC added that LB was happy to look over and give her	
	opinion on any applications that the Area Partnership receive	
	regarding educational initiative projects. IC asked if everyone was	
	happy with this. SB asked for clarification if the application from MGS	
	is now rejected or withdrawn. IC confirmed it is withdrawn. MGS are	
	keen to look at a project working closely with all primary schools in the	
	future. SB will seek further clarification and guidance on future	
	educational initiatives projects.	
6. Sub Groups		
· ·	IC stated that although it had not been easy to arrange meetings for	
	sub groups, he reminded members that the Area Partnership had a	
	year's subscription to zoom and added that if any member wished to	
	set up a sub group meeting to contact him direct and he would supply	
	the necessary details.	
	Active Travel – IC suggested a meeting be set up for January 2021 to	
	revisit core membership, priorities etc. Active Travel is still seen as	
	important and remains an important objective of the Area	
	Partnership, as highlighted in the Area Plan.	
	IC added that the electric bridge has now been opened up for bikes	
	which is in his opinion a positive benefit to the community. SB added	
	that the Just Eat bikes at the Brunton Hall had been the subject of	
	vandalism. A meeting had been held on Wednesday 23 <sup>rd</sup> November	
	2020 where it had been agreed that any further vandalism would be	
	reported directly to the local police, previously this was reported by	
	the bike company to the police in Edinburgh. CCTV will be used to	
	monitor the bikes and outreach workers in the area will engage with	
	young people to raise awareness of this issue. SB informed members	
	that electric bikes were still planned for the Brunton Hall although no	
	firm date for their installation had been agreed. East Lothian Council	
	are reluctant to move the bikes from this site to a new location as this	
	area of the Brunton Hall has been identified as a travel hub. BT	
	confirmed that SESTRANS was currently very busy with a lot on their	
	agenda. BT added that he was keen that a meeting of the Active Travel	
	sub group be held in January. IC confirmed he is happy to help set up a	
	zoom meeting for this sub group.	
	Health & Wellheing - IC/SP/IM had a mosting last weak to Beenla	
	<b>Health &amp; Wellbeing</b> – IC/SB/JM had a meeting last week re People	
	Know How who are a charity working from a headquarters in Ferry	
	Road Edinburgh, this was to look at the possibility of a pilot project	
	focussing on digital inclusion and befriending services. IC explained	
	there is a YouTube video that explains more about this work, and	
	provided this link <u>https://youtu.be/Zm6ZDZY1BDI</u> . People	
	Know How provide refurbished computers and tablets along with	
	training and support. IC added that it was explained that a 91 year old	
	lady has been receiving support to keep her in contact with family	
	abroad and helping reduce her feelings of isolation. The befriending	
	service offered is more than just a phone call and looks to provide	
	additional support based on the person's needs. JM explained the	

focus for H&W will be families, young children and the elderly. Looking at a broad spectrum of all ages. Priorities includes reducing social isolation, improving digital accessibility and encouraging resilience. JM added she continued to work with Support from the Start in Musselburgh. IC will keep members up to date on progress. JM confirmed she liked the work of People Know How and that it was not prescriptive, they find connections and go at the peoples own pace. They provide the confidence that is needed so people feel they are in safe hands. GA confirmed they are a good community charity and she was very positive about working closely with them. CS enquired if anyone more local as they appear to be an Edinburgh charity. IC confirmed they are based in Edinburgh but cover the whole of Scotland. SB added that they have secured a local office in the Recharge Youth and Community Centre in Church Street Tranent. CMc added she knew of someone who would benefit right now from this type of support and asked for contact details. SB added that People Know How will accept referrals from any source including self-referrals and added that he had a referral form that could be used by anyone that needed it. NM confirmed that Bridges Project have been referring young people and families to People Know How all through lockdown and in her opinion they had been brilliant at addressing these needs in the community. She added that they acted very quickly and always followed up with additional support where needed, she would definitely recommend them. IC indicated that this was very positive and good to know that NMc has a good working relationship with this charity.

**Budget/Priority** – IC informed members that while there had not been a meeting, he confirmed that energies were being applied to bring forward projects to the Area Partnership to address the current priorities in the Area Plan. He was however looking to hold a subgroup meeting in January 2021 to look at future projects.

**Sustainable Musselburgh** – GA provided an update to members. A meeting of the sub group had been held recently. The subgroup had recently contacted ELC Road Services around spaces for people and had been introduced to Liz Hunter who she found was really good. Paul Mathews who worked with Liz explained the "Musselburgh Active Toun" project. GA added that Jason Rose from the sub group agreed to go on the group. GA tried to contact BT as she understood that active travel would normally be the remit of the Active Travel sub-group and didn't want to stand on anyone toes. Jason will feed back to the group. GA confirmed she thought that it was going to be fantastic project when it happens.

GA added that the Sustainable Musselburgh sub group were focusing on the Musselburgh area including Wallyford and Whitecraig being a plastic free community and were working with both Jennifer Lothian and Caroline Davis to achieve this. GA informed members that she intended to contact the Musselburgh Business Partnership to examine ways that businesses can also be involved. MC replied that he was happy to have this discussion. GA agreed to contact MC regarding this. GA highlighted that the sub group continued to focus on concerns regarding water quality in the River Esk. Ga informed members that she was a member of a group set up by Colin Beattie to look at the water quality of the river esk and also a member on the SEPA stakeholder group on bathing water but that the main issue with the

	Park to look at planting apple trees as part of a Community Orchard.	
	Funding for this project will be discussed later as part of the Amenities	
	Service budget. IC thanked GA for her update and suggested sending	
	an email to SEPA to see what the suggested £3 million on	
	improvements had been spent on. GA advised as far as she knew most	
	of it was spent on misconnections to houses and buildings around	
	Brunstane Burn. And the historical issues of outflow pipes and toilets	
	connecting straight into river. IC will forward the email to SEPA to all	
	members.

Members discussed this and agreed that 100 families should not limit giving more if needed to a maximum of 200 families at £1000. This was voted on by members and approved unanimously.</li> <li>Meal packs in Wallyford, Whitecraig and Musselburgh £600</li> </ul>	

Wallyford and Whitecraig areas. This initiative would provide the ingredients for a starter, main course and desert along with a menu card for the families to cook for themselves. This help build resilience. It was proposed to offer a Christmas themed meal pack and to widen the area to include Musselburgh. The cost would be approximately £600. This was voted on by members and approved unanimously. Wellbeing Hampers £250 SB outlined this initiative also being organised by Connected Communities Staff to provide wellbeing hampers at Christmas to elderly members of the Community that had been identified through the Resilient Musselburgh work in the summer. This was voted on by members and approved unanimously. Children's Clothing £1,125 SB outlined the proposal by Connected Communities Staff working with Children First to provide winter clothing to 25 identified Children at a cost of £45 each, members had been made aware of this and additional information in an application form from Children First had been sent out to members. This was voted on by members and approved unanimously.

SB explained to members that he was also awaiting funding applications form the Bridges Project for £25,000 and the Musselburgh Business Partnership for approx. £19,000. SB will forward these applications to members when they have been received.

SB also mentioned the intention explained earlier to look at an initiative with People Know How on Social Isolation.

SB explained that he had been looking at priority projects that could be provided by the Road Services Budget.

This budget needs to be spent on Roads and Footways identified as adopted roads by the Council as Roads Authority. Due to Covid the Councils Road Services had no capacity to do work for the Area Partnership. SB then enquired about external contracts and two areas have been identified. 1. The slabbed areas of footway in very poor condition in Newbigging, these were on routes to school which is an Area Partnership priority and 2. Dropped kerb crossings.

Members unanimously supported this use of the Roads Budget.

GA made members aware that she had concerns regarding safe routes to Musselburgh Grammar School from Old Craighall and that this needed flagged to planning regarding the new development at Old Craighall.

AH made members aware that he had walked the Area of Wallyford Bing with Garry Inglis of ELC and enquired if SB had heard any more about the paths around Wallyford Primary School and the Bing area as this seemed to go on for ever. SB replied that he had not heard anymore.

AF made members aware that he had raised the mini roundabout at Fergusson Drive with Alan Stubbs the Road Service Manager who was looking at this area. JW replied that there was not enough room for a full roundabout and was unsure if proposals to introduce cycle lanes would make a difference? He also suggested to look at introducing access protection markings at existing dropped kerbs to stop people

	parking adjacent to them. SB asked JW what locations he had in mind and JW agreed to forward locations to SB. SB made members aware that he had recorded a Christmas message which was being played on Radio Saltire.
