SUBJECT: CIF Pump Tracks

1 PURPOSE

1.1 The purpose of this report is to provide an update and next steps regarding the proposed delivery approach for Pump Tracks utilising the capital budget in the 22/23 and 23/24 financial years following public consultation.

2 RECOMMENDATIONS

2.1 Members note the information provided and plans to bring forward Pump Track projects at identified locations subject to planning approval and full external funding confirmation.

3 BACKGROUND

- 3.1 A Pump Track is an off road cycling facility suitable for all ages and abilities from children on balance bikes to older young people and adults on any type of bike. It is an open facility that does not require any payment. The first asphalt Pump Tracks was delivered at Ormiston Park in 2021 and has seen significant usage by people of all genders and ages. The number of registered cyclists is increasing on an annual basis and there will be an increase in the profile and investment into the sport as a result of Scotland hosting the 2023 World Championships including a national cycling facility fund.
- 3.2 The Council budget set on 1st March 2022 includes a Capital allocation of £125k in 22/23 and £125k in 23/24 for Community Intervention Fund Pump Tracks. Following consideration of a reports through Asset Management Governance groups, the use of the funding allocated in the Capital plan aims to support the following principles:

- How to achieve equity of provision across the County with prioritisation of projects in areas of deprivation or that experience higher levels of anti-social behaviour.
- Where projects are coming from an identified community need.
- Opportunities to maximise the use of the Council Capital budget where external funding can be utilised.
- 3.3 The Scottish Government and sportscotland have launched a one off time limited £8 million fund to improve cycling facilities across the country. The national Cycling Facilities Fund will capitalise on the upsurge of interest in cycling by seeking projects that encourage people of all ages to ride bikes. It will also deliver a tangible benefit which is part of the wider policy objectives driving the forthcoming UCI Cycling World Championships, which will take place in Scotland in 2023. The fund aims to grow and develop club and community cycling for recreation as opposed to delivering cycle routes for transportation. Sportscotland can provide up to 50% of a project cost up to a maximum of £100k for local projects that are successful through their application process. The funding guidelines state that Local Authority applicants should meet at least 25% of the total project cost from their capital budget. Applications are accepted into two funding rounds annually (April and September) with the fund due to close when fully allocated.
- 3.4 To scope potential projects and in order to achieve the principles set out in section 3.1, the Council has considered either projects that were currently being proposed by community groups or other suitable projects that would meet local priorities. For the projects in Musselburgh, Tranent, Prestonpans and Haddington, a number of potential sites were identified and consulted on internally and externally in order to inform the most suitable option to bring forward for detailed consideration and feasibility. The sites were shared with Planning prior to public consultation to ensure there were no constraints that would restrict a project coming forward for a full application in due course. A special website was created to support the public consultation and information was shared through the Council's Corporate Communications channels, with representative groups and directly with young people through schools. A headline summary of the consultation feedback is provided below. The full consultation summary for each site is included in Appendices 1 - 4.

All the sites identified above are of Amenity or recreational designation. It is recommended that projects are taken forward at the highest scoring locations and a full planning submission is brought forward. The exact area for a Pump Track within these sites will be subject to further survey and investigation. Detailed proposals and design will be included as part of the formal Planning submission which will provide further opportunity for consultation and representation from representative groups, members of the community and local residents.

- 3.5 Funding applications were submitted to sportscotland for the projects in Musselburgh, Tranent, Prestonpans and Haddington by the deadline of 1st September 2022. A contribution of £50k has been requested for each project from sportscotland to match the allocation of the Council capital funding. Projects in North Berwick (community led) and Dunbar have secured in principle funding from sportscotland and will progress to a formal planning submission in due course. The successful delivery of any of the individual project will be subject to the following:
 - Total individual project funding confirmed
 - Procurement
 - Statutory permissions confirmed including Planning / Building Warrants where appropriate.

4 POLICY IMPLICATIONS

4.1 The investment into the enhancement of cycling infrastructure contributes towards outcomes in the East Lothian Plan. In particular this supports East Lothian's children and adults living healthier and more active lives.

5 EQUALITIES IMPACT ASSESSMENT












7: Would the proposed pump track in Haddington help you, or a family member be more active more often?












7: Would the proposed pump track in Prestonpans help you, or a family member be more active more often?



















HOW SUPPORTIVE ARE YOU OF THE PROPOSED PLANS FOR THE NEW PUMP TRACK AT MUSSELBURGH





WHAT IS YOUR PREFERED SITE LOCATION IN MUSSELBURGH




