1 PURPOSE

1.1 This report is to update Elected Members on the approval of Section 10 annual grant funding to Third Sector partners for 2023/24.

2 **RECOMMENDATIONS**

2.1 Elected Members are asked to note the allocation of annual grant funding from the Children's Services Section 10 budget outlined in Appendix 1.

3 BACKGROUND

- 3.1 Section 10 of the Social Work (Scotland) Act 1968 allows local authorities to make grants to voluntary (third sector) organisations whose sole purpose is to promote social welfare.
- 3.2 Organisations have applied for 1 year funding in 2023/24 under the following partnership priorities:
 - Improving children and young people's mental health and wellbeing.
 - Supporting parenting and strengthening family resilience.
 - Reducing inequalities for our children and young people.
- 3.3 Organisations were also asked to outline how their application would meet one of the Children's Services priorities:
 - We will ensure our practice and our service prevents the need for children and young people to leave their family where this is safely possible.
 - We will build capacity in internal care resources

- We will bring children and young people back to East Lothian from external placements.
- 3.4 Children's Services work collaboratively with other council services and Third Sector partners to deliver protective and supportive services for children and their families in East Lothian. By maintaining a shared vision and strong partnership with the third sector we are able to build capacity and often attract additional funds to develop specialist services for children.
- 3.5 The Children's Services Management Group in partnership with representatives from Education and Communities, scrutinised the applications against the criteria. The successful organisations were assessed as being best placed to meet the relevant priorities and to support vulnerable children and their families.
- 3.6 The outcomes of this process and the organisations approved to receive Section 10 annual grant funding for 2023/24 are set out at Appendix 1.
