SUBJECT:	Application for Variation of Public Entertainment Licence at Cockenzie House and Gardens, Cockenzie	

1 PURPOSE

- 1.1 To advise the Sub-Committee of a request from the Applicant to vary the Public Entertainment Licence currently in place at Cockenzie House so as to-
 - Extend the licenced area to include the Gardens
 - Permit live music performances within the Gardens
 - Permit a portable sauna within the Gardens.
- 1.2 To request that the Sub-committee consider all the information presented to them and in light thereof determine the application.

2 **RECOMMENDATIONS**

It is recommended that -

- 2.1 In light of the information set out in this report (and with reference to paragraph 3.6 below) and the report by the Licensing Standards Officer, that the Sub-Committee determine the application.
- 2.2 If minded to grant, that the Sub-Committee considers whether it would be appropriate to impose additional conditions on the current Public Entertainment Licence, such as duration or frequency of use, as an appropriate and necessary measure to prevent public nuisance. Members are referred to the report by the Licensing Standards Officer for suggestions as to such conditions

3 BACKGROUND.

- 3.1 A Public Entertainment Licence has been granted to Cockenzie House and Gardens, running from 6 October 2020 and expiring on 5 October 2023.
- 3.2 The current Public Entertainment licence only applies to the building forming Cockenzie House, and covers activities such as film shows, comedy acts, drama, book launches, talks, fairs, exhibitions, fashion shows, tours, nature walks, seminars, workshops, and general community use. The Applicant .held a number of events in the garden area of the property in 2022 which were not covered by the terms of their current licence, and there are plans for similar events to take place in the garden area this year. Following advice from the Licensing Standards Officer, who has submitted a report to the Sub-Committee, the Applicant has lodged the present application to vary the terms of their current licence.
- 3.3 The Licence, if varied by the Sub-Committee, will only run to the present end date of the licence and the Licensee shall require to apply for renewal of the Licence (whether or not varied), in October 2023. The present application has no effect on the duration of the licence.
- 3.4 There have been a number of complaints about the events held last year and there are ongoing concerns about the proposed events this year. The objections received in respect of the present application are annexed as Schedule 1 to this report. Members are referred to the report from the Licensing Standards Officer for more details on the history of these complaints and the present situation.
- 3.5 The Applicant was advised in 2022 to check all relevant permissions were in place. The Applicant did apply for and obtain seven occasional liquor licences in respect of the proposed events at the Property in May 2023 and was advised at that time that a public entertainment licence may also be required. The Applicant failed to put consents and licences in place and was advised to do so before he continued. He was not issued with any formal enforcement but guided on several occasions to seek independent legal advice. This has resulted in the time pressure to deal with the present application which otherwise could have been processed well in advance of any proposed events. It is noted that the Facebook submissions incorrectly state that permission had been refused due to noise complaints, leading to a backlash of negative and accusatory comments on social media about complainers. Obviously, no decisions have yet been made as the application is only now coming before the Sub-Committee.
- 3.6 In addition to the usual considerations in determining the application, officers would highlight the following issue for consideration by the Sub-Committee-
 - Is the addition of the requested activities to the Public Entertainment Licence suitable given the nature and location of the premises in a residential area, and would the addition of such activities have a

detrimental effect on surrounding residences in relation to disturbance. If so, should additional conditions be added to the licence to prevent this

3.7 The Sub-Committee may grant the application to vary the licence, or refuse it. If minded to grant, the Sub-Committee may wish to consider imposing additional licence conditions along the lines of those suggested in the report from the Licensing Standards Officer.

Subject: CIVIC GOVERNMENT (SCOTLAND) ACT 1982 REPORT – PUBLIC ENTERTAINMENT LICENCE – VARIARION – PE/007/20 Cockenzie House and Gardens, 22 Edinburgh Road. Cockenzie, EH32 0HY

An application has been received for the variation of the Public Entertainment Licence held by the company Cockenzie House and Gardens for the use at this location. The application has been made by the company Cockenzie House and Gardens listing Marietta Di Ciacca, Cheryl Campbell and Craig Hodgson as directors, partners and other people responsible for management.

The application is to vary the current public entertainment licence to include the outside garden areas, add live performances and a portable sauna in the rear garden as licensed activities.

Cockenzie House and Gardens describe the use of the premises on their facebook page as:

"We offer practical and elegant spaces for hire - we have 46 studios for artists, small businesses and therapists, our Willow Room which is fantastic for parties and two self catering cottages. The new onsite Cafe, Cafe Filly, is now open for all your coffee, breakfast and lunch needs. Please contact them directly on **Content of Sector**. Dog Friendly, Cafe Venue and Gardens!"

The facebook page contains weekly posts in relations to events, exhibitions, markets, weddings and wedding fairs, children's events including carnivals and bouncy castles, mini retreats, wellness events, markets, Doggies Day out events, Christmas events and shopping both within the house and in the gardens. It appears that the main purpose of the premises is to provide units for businesses, events and event spaces for use or hire along with a café. Some events are free to attend and have commercial traders others incur an entry fee or a fee for hire. There is currently an events co-ordinator or similar position employed at the premises.

From the beginning of June – end August 2022, a live and amplified music festival took place outdoor in the gardens of Cockenzie House on recurrent Saturdays and Sundays. During this time complaints from four separate residents were received. The complaints related to noise and the disturbance caused by the amplified music, bands shouting and swearing. A complaint was also received in relation to drug taking and persons taking their own alcohol into the event. A formal complaint was then received at the termination of the event detailing a significant impact from the repeated noise every weekend.

A visit was conducted with the event organiser and applicant Mr Craig Hodgson in relation to the occasional licences granted under the Licensing (Scotland) Act 2005. The visit took place on 2nd August 2022 where complaints, noise levels, drug use and people bringing alcohol into the event were discussed. Guidance was given to use stewards for the event and to take a vigilant approach to drug taking. Mr Hodgson was advised to monitor noise levels so as not to cause a disturbance. Mr Hodgson was also advised to check that he had all other relevant permissions in place for the event as the visit was only in relation to the alcohol licences.

Mr Hodgson was advised that, whilst not a mandatory forum for this type of event he would benefit in the future by submitting an event notification form to East Lothian Council to allow a Safety Advisory Group (SAG) to discuss the event and provide guidance and support from multiple departments and agencies.

Police Scotland Licensing Officer was invited to the meeting on 2nd August 2022, but declined to attend.

In May 2023, Mr Hodgson made applications for 7 occasional licences for the event "EH32 Live" which were heard at the Licensing Board on 25th May. The Licensing Board granted the licences with additional conditions. Prior to the licensing board, Mr Hodgson was informed by phone that a public entertainment licence may be required for the event and that the current public entertainment licence at Cockenzie House did not include the gardens or live/amplified music performances. The occasional licences did not given permission for the whole event, the licences only granted permission to sell alcohol at the event.

On Saturday 27th May 2023, a wedding in a marquee took place at the premises with the provision of alcohol. This was followed on Sunday 28th May by a club land event with live amplified music and the provision of alcohol.

Three separate complaints were received in relation to the wedding (no Public Entertainment Licence required but considered in this report due to the noise element) and one complaint was received in relation to the club land event. A total of 4 complaints from different complainers over the weekend. The complaints in relation to the wedding detailed

noise nuisance and the terminal hour of the noise being very late. The complaint in relation to the club land event detailed the music was extremely loud, the DJ was shouting and swearing through the microphone and that patrons were shouting and swearing back.

I contacted Mr Hodgson in relation to his responsibilities as the holder of the occasional licences that permitted the sale of alcohol at the events. Details of the complaints were discussed. Mr Hodgson said he did not think that he was responsible for the noise at the wedding as he was not the event organiser and that was handled by the wedding coordinator employed at Cockenzie House. I explained to him that he, as licence holder, was responsible for upholding the all the licensing objectives including preventing public nuisance and that he needed to take serious responsibility and control of this aspect.

On 29th May 2023, I spoke with Mr Hodgson on the phone. Guidance was given that he could apply for a temporary Public Entertainment Licence if a suitable application could not be made to vary the current Public Entertainment Licence. It was detailed that an application for a temporary licence would still require to go through the statutory consultation period before it could be either granted or be sent to a sub-committee hearing for determination.

On 30th May 2023, the Licensing Standards Officer received a copy of an application to vary the Public Entertainment Licence at the premises for consultation. This was 11 days prior to the purposed event start date.

On 31st May 2023, I was made aware that MSP Craig Hoy had also received a complaint from a resident in relation to the "EH32 Live" event.

On 1st June 2023, I received an email from Mr Hodgson asking for advice. He detailed that he had been at a meeting at Cockenzie House where he had been told that his events could not go ahead. As a Licensing Standards Officer is not permitted to give any legal advice and can only assist in guidance as to what is required under licensing legislation, I advised him to seek advice from a qualified solicitor. He was also advised that a licensing board is only able to determine matters in relation to the sale of alcohol and not matters under other legislation.

Following the Licensing Board hearing and media coverage of the grant of the occasional licences, I received 2 complaints in relation to the event "EH32 Live" which took place in 2022. The complaints detailed the nuisance and disturbance caused by the nature, frequency and duration of the music event, mostly linked to noise nuisance and parking issues. The complainers wished to remain anonymous and one wished to withdraw the complaint due to fear of repercussions.

On 5th June 2023, I contacted Ms Di Ciacca (Manager and applicant) and Mr Hodgson by email to ascertain if they intended on going ahead with the planned "EH32 Live" events as well as a Kids Karnival due to start on Saturday 10th June 2023 given the licensing issues. The carnival advertised a bouncy castle and carnival games which were also unlicensed activities. It was explained in the correspondence that holding the events would be an offence under Section 7 Civic Government (Scotland) Act 1982, a criminal offence enforceable by police should they wish to take action. Mr Hodgson was asked if he intended to cancel the planned events or proceed with them. Police were also included in this correspondence but did not to my knowledge respond. This was not a request or notice to stop, but given as guidance as to what the legislation states.

On 6th June 2023, Mr Hodgson emailed the Licensing Team confirming that he had decided to suspend the events until the required consents were in place.

On 8th June 2023, a post was published on the facebook page "EH32 Live" detailing that all EH32 Live events had been ceased by East Lothian Council due to environmental health and the planning department backtracking due to a small number of noise complaints and class use of the gardens. A link to a petition was posted as well as link encouraging members of the public to raise formal complaints to the council in regards to the event not being able to run. Full post detailed in appendix 1.

The post at the time of writing had generated 68 reactions, 39 comments and 106 shares. The majority of comments were outrage and anger directed at the Council and noise complainers. This response was generated by inaccurate information that the council had stopped the events and are to blame for the cancellation. It demonstrated a lack of understanding of the statutory processes and permissions required to hold the event by the author of the post.

To be clear, no enforcement took place from the Licensing Standards Officer, only guidance was given in relation to the licences required. It was the applicant's decision as to whether to proceed or cancel the events. It is the event organiser's responsibility to ensure that all relevant permissions are in place prior to commencing an event.

Following the post, East Lothian Council Feedback team received numerous complaints in relation to the cancellation of the event.

On 15th June 2023, another post was added to "EH32 Live" facebook page as detailed in appendix 1. The post thanked everyone for the overwhelmingly positive response to the event. It detailed that the events in 17th-18th June and 24th-25th June would be cancelled and that there had been positive news about the situation. It was signed off as Craig and the EH32 Team.

On 16th June 2023, Mr Hodgson contacted me asking for information on a temporary public entertainment licence. Guidance on the application process including consultation and timescales was sent to him. He was advised for any further advice to contact a licensing agent or solicitor. On 19th June Mr Hodgson asked me to confirm the correct public entertainment resolution which was sent to him.

On 21st June 2023, Mr Hodgson contacted me asking of the EH32 Live events would be exempt from the requirement to hold a public entertainment licence as they were small scale. He also asked if he was able to start trading at the bars and if he could run the bars with a "busker" plating music. I informed Mr Hodgson that in my opinion the events would not be exempt under the current resolution. I also asked him to consider other permission required to run the bars from other departments and what a busker is, suggesting that a person performing at an organised event may not be considered a busker. Again he was informed that the information I supplied was guidance, it was not enforcement and that he should seek legal advice.

I am unaware if the mobile sauna proposed to be used in the garden has been in use already. No complaints have been received in relation to this activity. I have no details on the proposed hours/days of use for the sauna, size or capacity. It is unclear how people will access the sauna, what changing facilities will be available in the outdoor location and if persons will be able to see into the Sauna from the outside.

Given the information above, I recommend the committee review the content of the application to vary the Public Entertainment Licence and considered the following recommended conditions:

- Restrictions on music events such as in duration or frequency may be appropriate and necessary to prevent public nuisance. For example:
 - Music and performances in the outside areas including temporary structures is limited to one weekend only within a fortnightly/monthly period.
 - Music and performances in the outside areas including temporary structures is limited to a Saturday or Sunday only each weekend
 - Music and performances in the outside areas including temporary structures is limited so as not to coincide with the same weekend as a wedding (Friday-Sunday inclusive)
- Use of the sauna is restricted to 10am 8pm so as to prevent any noise nuisance to surrounding residential areas from persons using the facility outside.
- Adequate changing facilities must be provided

In addition I ask the following of the applicant:

• Does the variation to add the additional activities requested meet their needs. It has been identified that other activities such as bouncy castles and carnivals that are not included in the variation or current list of activities. I recommend that the applicant review the resolution in order to ascertain all the activities that require to be listed on the public entertainment licence. A new application would be required to add additional activities.

We have started a petition to get support from the community so we can prove to the council how much this event means to everyone. We hope that this will get us answers and possibly fast track the application. The petition is on the link below. You need to verify your email address after you have filled this out, otherwise the signature will not count. The email does take a while to come through after. I refer to your consultation request of 12th June 2023 in connection with the above and would advise as follows.

I have significant concerns regarding the proposal to allow live entertainment in the form of amplified music and/or amplified speech for an external venue within a mixed use area with numerous noise sensitive receptors in close proximity. There are little, if any, mitigation measures in place to contain noise within the grounds of Cockenzie House and gardens and to minimise noise impacts on residential neighbours. Numerous complaints were received in 2022 during the EH32 Music Festival and further complaints have already been received for events held over the weekend of Sat 27th and Sunday 28th May 2023.

Given the number of complaints received previously and the potential impacts upon amenity going forward it is my opinion that the number of events (22 between June-August 2023) is excessive and should be restricted via conditions attached to any grant of consent as follows:

- Live music within the garden grounds shall only be permitted between 01st June and 31st August and at no other time
- Live music shall only be permitted on a Saturday and at no other time
- Live music within the garden ground shall only be permitted between 1400 and 2000 hours and at no other time
- Consent for live music events within the garden grounds shall be for a temporary period until 31st August 2024. Thereafter no live music events shall be permitted within the garden grounds.


