SUBJECT:	Update on Funding for Communities 2024/25

#### 1 PURPOSE

1.1 To provide an update on allocation of grant funding from the One Council Partnership Fund.

#### 2 **RECOMMENDATIONS**

2.1 Members are asked to note the amendments to the awards to First Step and Bridges as set out in this report.

#### 3 BACKGROUND

- 3.1 The Members Library Report (33/24) Funding for communities 2024/245 set out the funding awards from the One Council Partnership Fund. Included in the awards were grants of £135,00 to First Step (application was for £208,000) and £47,262 to the Bridges Project (application was for (£76,124).
- 3.2 It is intended to transfer funding for First Step to the Early Learning and Childcare service with a view to the service and First Step setting up a Service level Agreement for long-term funding. Following discussions between First Step and the Early Learning and Child Care service it has been agreed to increase the award to First Step by £60,860 to £195,860. The Early Learning and Child Care service will directly support First Step to develop a business model that is sustainable, maximises external finance sources, aligns with the service's expectations and delivers a collective vision for early help and support for East Lothian. This will be done taking a wider lens of the totality of family support offers in Musselburgh.
- 3.3 The Bridges Project had applied for £76,124 to employ two officers on its Way2Work project. Since the award of £47,262 does not cover the full

cost of two officers the Bridges Project asked for the grant to be reduced to £38,000 which will cover the cost of one officer. East Lothian Works has had discussions with the Bridges Project about the possibility of further support being provided through the service.

3.4 An amended list of awards is shown in Appendix 1. The total grant awards has increased from £691,853 to £743,451, and with the addition of the Service level Agreements and contract payment to East Lothian Advice Consortium the total payment from the One Council Partnership Fund has increased from £1,322,778 to £1,374,376.
