1 PURPOSE

- 1.1 To present petition PET0224 to the Petitions and Community Empowerment Review Committee for consideration. The petition is entitled 'Retain Fortnightly Green Bin Collection in East Lothian'.
- 1.2 The petition text reads:

Retain fortnightly green bin collection, as a change to every three weeks could have a significant impact on our environment and the cleanliness of our local communities. A reduction in waste collection services could lead to an increase in waste related issues, such as littering and fly tipping, vermin infestation, and even health hazards due to rotting waste.

2 **RECOMMENDATIONS**

2.1 That the Committee consider the petition and takes action as required.

3 BACKGROUND

- 3.1 A petition was submitted by Catherine King, principal petitioner, on 6 May 2024, and was deemed to be competent. The petition had been scheduled to be heard at the meeting of the Petitions and Community Empowerment Review Committee on 17 June 2024, but was rescheduled due this meeting falling within the pre-election period.
- 3.2 At the time of submission, there were 2450 signatories. At the time of writing this report, there appear to be 2782 signatories to the online petition.
- 3.3 Further details of the petition are contained within the petition form at **Appendix 1**. The Lead Petitioner included some comments from petition signatories in the petition form, and further comments can be found

We discussed by phone call and his assistant has sent me this paperwork. |
| Please provide more information about your petition | Nappies, female sanitary products and adult incontinence pads are not recyclable. The new system is discriminatory to any family affected by this, as we are asked to store them and bag them for collection. Why are families expected to handle waste in this manner, when previously we could bag it and leave it in our bin, then wheel out the bin discreetly. The new service does not provide this and is completely unworkable. Due to smells, flies, birds etc. ELC is offering a home visit to families to check they are using their recycling bins and to see how much incontinence waste there is – this is completely unacceptable and discrimination against the most vulnerable in society. There have been significant posts on social media where the system is not working. It also seems unfair to go |
