Dear Team dealing with objections to the MFPS,

I write to object to the recently published Musselburgh Flood Protection Scheme. I am a resident of Musselburgh, albeit not directly beside the river or the coast. I write also as an ELC Council Tax contributor and out of concern for my neighbours who will be directly affected by any installation of a concrete barrier wall. I am not directly by the riverside but will be within earshot of any pile-driving due to take place by the riverside (see below\*).

I object to the published scheme because:

- I regularly walk along the Esk riverside and this was one of my main reasons for choosing to live here. I have no desire to see a concrete wall and would prefer a nature-based solution;
- The land adjacent to the river is in many parts 'common good land' and as such, any interruption to their usage should be compensated for - is this going to happen and if so, from which funding source (but not from council tax of course)?
- \* For the duration of the scheme (an estimated five years until completion?!) it will involve extensive pile-driving along the riverside. I do not want to hear this for the next five years. My house is situated between Queen Margaret University ([REDACTED] above and behind me) and the river below (same distance). I currently hear the pile-driving every day taking place at QMU. I do not wish to have the same noise coming from the river;
- I do not agree that the scheme is the most cost-efficient option and am concerned that this will increase our Council Tax;
- I have not had the opportunity to access the alternative proposals that were ruled out when the EIA was being put together;
- I am unhappy that when residents asked to see the data underpinning the scientific calculations made by the project team that these requests were ignored. Is this information being withheld?;
- I believe that man-made interventions cannot prevent flooding downstream – I would prefer the focus to be on more preventative work upstream to slow and/or store the water before it reaches Musselburgh.

### **Musselburgh Flood Protection Scheme Notification**

Thank you for your letter of 14/03/24. We are writing to object to the recently published Musselburgh Flood Protection Scheme. We are directly affected by the scheme both because our home is shown in the flood maps as at risk of flooding, and because we constantly use the many amenities of Musselburgh that would be impacted by the scheme.

These are the grounds of our objections:

#### **Conflict with Scottish Government policy**

According to the Minister Mairi McAllan (last December) "The Scottish Government recognizes the importance of natural flood management (NFM) measures in reducing, slowing or otherwise managing flood waters across catchments and along the coast while also delivering multiple environmental benefits." NFM could include various techniques to slow the flow of the river through the catchments and to encourage the natural dune system along the coast, but these possibilities have been discounted, putting the MFPS in conflict with Scottish Government policy.

Scottish Government guidance says that a range of scenarios should be included, yet the MFPS is tied to a 1:200-year event. The Council has thus judged what is necessary protection without being able to consider a range of options – again in conflict with Scottish Government policy.

#### **Conflict of interest / Lack of proper process / Lack of transparency**

The engineers appointed to design the MFPS were allowed to write the Environmental Impact Assessment (EIA). This is a clear conflict of interest and incompatible with good governance. Furthermore, the engineers carried out an options appraisal that ruled out all alternatives to the current scheme, in which they have a vested interest, without those options being made available for public scrutiny or debate.

In January this year, the Council agreed to the scheme progressing, even though it had not seen the full EIA, meaning that the decision had no proper basis.

Requests by local residents to see the data the project team is using in its scientific calculations have been ignored.

East Lothian Council has commissioned a report on the coast from Dynamic Coast, but this report has not been made publicly available, which means that the Council is not being open about the evidence on which it is basing major decisions.

The scheme has become entangled with the Musselburgh Active Toun (MAT) proposals, which contribute little if anything to flood protection. Significantly, planning permission should be required for the proposed MAT paths and bridges, but the flood scheme has apparently been deemed to give those permissions, and no information has been made public about which parts of the MAT will bypass planning on account of being included in the flood scheme. Bypassing planning permissions, even if legal, is itself a case of disregard of proper process.

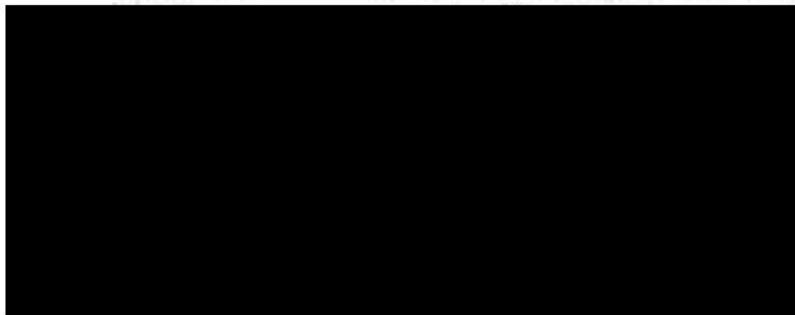
No proper breakdown of the soaring cost of the project has been made public.

### **Absence of cost controls**

The anticipated cost of the project is constantly escalating. It has already topped £100 million, and the Council has been warned that it will probably rise further. The Council has apparently voted the project through without having a clear idea of the final cost and without imposing a cap.

I am writing to object to the Musselburgh Flood Protection Scheme. I am a Musselburgh resident who regularly uses public services in the town but most importantly, I am a taxpayer who demands accountability from those in government and who spend on my behalf. Furthermore, I have concerns about the environmental and public impact of the proposed scheme.

I object to the published scheme because:

No alternative methods of prevention have been proposed and thoroughly examined beyond the 'Preferred Scheme'. How can residents support any council proposal without alternates to consider?

Transparency has lacked throughout perfunctory consultation processes. Methods of communication have been insufficient (see website FAQs) and printed guides have served as marketing in preference to balanced information.

Legitimate environmental concerns have been dismissed without open, honest discussion. Jacobs themselves have undertaken much more environmentally considerate methods, yet Musselburgh is to settle for less. How can ELC expect residents to have confidence in the scheme when our concerns and suggestions have been sidelined?

Costs continue to rise - with no safeguard, and no breakdown. Considering current economic pressure and cuts to public services, it is beyond belief to throw vast amounts on a '1-in-200yr' risk.

How can ELC justify the construction and expense of any flood prevention scheme while continuing to green-light extensive housing developments which affect the water table? I have no confidence in ELC's intentions to 'protect' Musselburgh when such duplicity occurs.

Access to local services such as schools, libraries, and healthcare, will be disrupted for an extended period of time due to road closures and diversions in already congested areas. It is acceptable to assume emergency service access will be affected and therefore increased risk to life is perceivable.

I am writing to object to the recently published Musselburgh Flood Protection Scheme. As a resident within the flood maps, just two minutes walk from the Esk River, I will be directly affected by the proposals sent by your office, reference CG/114811, dated 14 March 2024. Furthermore, as a tax payer I am disgusted at the cost of these proposed measures.

My main reasons for objecting to the published scheme are:

- There has not been sufficient investigation in to natural measures that could be used for the scheme. What is proposed will have a considerable and incredibly damaging affect upon the natural area with a huge environmental impact
- As mentioned above, the costings for the proposed scheme are unbelievable - I do not believe due diligence has been used when exploring cost effective measures. I would welcome your response on how this work has been proposed and which organisations you have contacted in developing the proposal for works. Furthermore, where is a breakdown off the proposed work at a cost of £103,535,000?
- The Scottish Government & COSLA working group on flooding has recognised the model of uncapped funding (known as Cycle 1) allows project consultants/developers to expand flood schemes into much larger, and more costly, projects. The escalating costs of this project should be scrutinised and capped to prevent further inflation of project and costs.
- I do not believe that East Lothian Council and partners have properly investigated all measures. I understand that East Lothian Council has commissioned a report on the coast from Dynamic Coast, but this is not yet available publicly – why and how is the Council making a decision without being open about all the evidence?
- The Council was informed that Natural Flood Management (NFM) should be restricted to 3 interventions (use of 2 small reservoirs in the Pentlands, and a tree-catcher in Dalkeith Country Park). NFM could include a whole range of techniques to slow the flow of the river throughout the catchments, and to

encourage the natural dune system along the coast. The fact these were discounted at the start is wrong and the situation is made worse by the exclusion of NFM decided upon in October.

- The Council halted inclusion of NFM on the advice of the project team in October 2023. The evidence to support this was a report on the Eddleston Water project. That report is flawed, and the science behind the report was presented to the Council in a misleading way. NFM can and should take centre-stage in flood protection.
- All the indications are that the use of NFM, nature-based solutions and a flood resilience (rather than prevention) approach are preferred over building flood walls. Even in massive river catchments like the Severn, these approaches are being discussed and trialled. The flood walls in Brechin (built/renewed 2015) recently failed. The flood gates in Perth recently failed. Man-made interventions cannot prevent flooding downstream – we need to do more upstream to slow/store the water so it doesn't rush down through the town.
- The Scottish Government is heading towards NFM. On 23 December 2023, [the Minister stated](#) "The Scottish Government recognizes the importance of natural flood management (NFM) measures in reducing, slowing or otherwise managing flood waters across catchments and along the coast while also delivering multiple environmental benefits." Why is ELC not in step with the Scottish Government?

I am writing to object to the recently published Musselburgh Flood Protection Scheme.

I live in [REDACTED] and my home is therefore not at risk of flooding. However I walk daily on the river paths and along the beach with my dog and with friends and family. I love the wildflowers, trees, insects birds and wildlife that Musselburgh is enriched by. The rare toothwort is a parasitic plant with beautiful purple petals. It is growing at the base of a number of mature trees right on the banks of the stretch just beyond the site of the old Mills. These mature trees not only suck up gallons of water they host so much flora and fauna that will be lost or disturbed if the plans go ahead in the proposed form.

I have been closely observing the plans for the flood defences and feel they are not appropriate. Too much concrete and measures that many experts agree can exacerbate flooding such as narrowing the river, removing trees and expanding hard landscaping. Expecting the Council to open sluice gates to deal with any flood water that gets past the walls is madness. Take a look at the roads and gulleys that are currently flooded after every rainy day. The council is unable or unwilling to deal with that. Stoneybank Terrace and Avenue gutters are constantly flooded and the road under the rail bridge on Monktonhall Road is dangerously awash.

There are other riverside towns where similar schemes have failed. Brechin suffered dreadful flooding despite previous measures taken to prevent this using concrete walls. I have family in the area and last years floods were devastating.

The brochures created have stylised pictures that do not show the true dimensions and plans but present in a way that is misleading and minimises the true impact - heights of walls and destruction of trees. Thanks to the investigation and hard work of a few residents a more accurate interpretation of the engineers measurements has been shared with concerned residents. The canalisation of the lower reaches of the Esk and the inability of those walking alongside to see the river easily are disastrous for wild life and residents alike.

The thought of years of noisy and dirty construction work that costs a fortune and ultimately results in long stretches of concrete walls and a narrow river we can't enjoy is very depressing.

Not working with areas further up river on a solution for possible future flooding is a mistake.

Flood plains and meanders are needed the length of the Esk. There are also better alternatives to concrete walls on the beach to protect Musselburgh from rising seas.

We cannot accept that the ELC can proceed with a project that leaves the contractor to make these decision .The contractor is driven by profit not public interest .If the ELC abdicate responsibility to the contractor about tree felling it calls into question what other aspects of the contract they will wash their hands of .This cannot be allowed to proceed .where is the Green agenda in all of this .The ELC must furnish us with facts if we are to evaluate the impact of this project and we think they are failing us and it should be returned to the favoured contractor and corrected .Surely as the purse holder the ELC has a duty of care to the citizens of East Lothian to set out the scope of the work rather than allow adhoc changes to be made as the contract evolves.

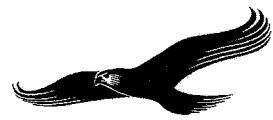

### **MUSSELBURGH FLOOD PROTECTION SCHEME 2024**

Pursuant to Section 60 and Schedule 2 of the above legislation, East Lothian Council proposes to make the above flood protection scheme ('the Scheme').

The Scheme comprises flood walls, flood embankments, replacement bridges, reservoir modifications, a debris trap, surface water pumping stations, culverting, repairs to existing structures, erosion protection measures, seepage protection measures, drainage works, landscaping works, road works, accommodation works, and environmental mitigation measures.

The Scheme will generally reduce the risk of flooding to in the order of 3,200 residential and non-residential properties in Musselburgh up to, and including, a 0.5% AEP (Annual Exceedance Probability) Flood Event (which is also known as a 1 in 200 year return period flood event) from the River Esk, Pinkie Burn, Musselburgh Mill Lade, and Firth of Forth plus an allowance for climate change.

East Lothian Council is required to serve a statutory notice upon you with regard to the Scheme under the terms of the relevant legislation. A copy of this notice is attached. The notice will be published on Thursday 21 March 2024 and any person may object to the Scheme on or before Wednesday 24 April 2024 as outlined in the attached notice.

**The Nature and Location of the Scheme**

The Scheme operations comprise the construction of flood walls, flood embankments, replacement bridges, reservoir modifications, a debris trap, surface water pumping stations, culverting, repairs to existing structures, erosion protection measures, seepage protection measures, drainage works, landscaping works, road works, accommodation works, environmental mitigation measures, and demolition of existing structures.

The Scheme operations are to be located:

- At Rosebery reservoir on the River South Esk, near the Temple, Midlothian;
- At Edgelaw reservoir on the Fullarton Water and Redside Burn, near Temple, Midlothian;
- On and nearby the River Esk in Dalkeith Country Park, near Whitecraig;
- On and nearby the River Esk in Musselburgh, between Inveresk Estate and the mouth of the River Esk at the Firth of Forth;
- On the Musselburgh Mill Lade, between the Eskmills weir and its discharge into the Pinkie Burn;
- On the Pinkie Burn in Musselburgh, between Pinkie Playing Fields and its discharge into the River Esk;
- On the Musselburgh coast between the mouth of the River Esk and the Brunstane Burn;
- On the Brunstane Burn, between Edinburgh Road and the mouth of the Brunstane Burn at the Firth of Forth; and
- On the Ash Lagoons Seawall in Musselburgh, between the mouth of the River Esk and Morrison's Haven.

In pursuance of the Council's functions under Part 4 of the Act, the Council considers that the benefits likely to be derived from carrying out the operations of the Scheme will be to generally reduce the risk of flooding to in the order of 3,200 residential and

non-residential properties in Musselburgh up to, and including, a 0.5% AEP (Annual Exceedance Probability) Flood Event (which is also known as a 1 in 200 year return period flood event) from the River Esk, Pinkie Burn, Musselburgh Mill Lade, and Firth of Forth plus an allowance for climate change.

The Scheme is likely to have a significant effect on the environment and is therefore subject to an Environmental Impact Assessment (the "EIA"). The results of the EIA have been incorporated into an environmental impact assessment report (the "EIA Report") which is included with the other Scheme documents.

- Disclosure of the nature of the objector's interest in the land; and

### **Process and Possible Decisions**

The Council is responsible for taking any decision to confirm the Scheme in accordance with Paragraph 4(1) or 9(1) of Schedule 2 of the Act, whereas the Scottish Ministers are responsible for taking any decisions to confirm the Scheme in accordance with Paragraph 7(4) of that Schedule.

Where the Council receives no valid objections to the Scheme, then the Council must make the final decision to confirm or reject the Scheme.

Where the Council receives a valid objection to the Scheme, the Council must consider the objection and make a preliminary decision to either:

- a) Confirm the Scheme without modification; or
- b) Confirm the Scheme with modifications; or
- c) Reject the Scheme.

Where an objection is received from a relevant objector, who is a person to whom Paragraph 5(6) of Schedule 2 of the Act applies, the Council must notify the Scottish Ministers of the preliminary decision. The Scottish Ministers must then decide whether to consider the scheme or not. If the Scottish Ministers decide to consider the Scheme and valid objections remain, then the Scottish Ministers must cause a Public Local Inquiry to be held.

After considering the outcome of the Public Local Inquiry, the Scottish Ministers must make the final decision to:

- a) Confirm the Scheme without modification; or
- b) Confirm the Scheme with modification; or
- c) Reject the Scheme.

Where the Scottish Ministers decide not to consider the Scheme the Council must hold a hearing to consider the Scheme. Following the outcome of the hearing, the Council must make the final decision to:

- a) Confirm the Scheme without modification; or
- b) Confirm the Scheme with modifications; or
- c) Reject the Scheme.

Notification of the final decision, whether made by the Council or the Scottish Ministers will be given to every person given notice.

Insofar as the Scheme involves "development" as defined by Section 26 of the Town and Country Planning (Scotland) Act 1997, Scottish Ministers must direct that planning permission under Section 57 of the Town and Country Planning (Scotland) Act 1997 shall be deemed to be granted, either upon their confirming the Scheme or following a request by the local authority where they have confirmed the Scheme. The deemed planning permission shall be subject to such conditions (if any) as may be specified in the direction.

For the purpose of Regulation 11(3) of the Regulations, the estimated cost of the Scheme operations proposed to be carried out is one hundred and three million five hundred and thirty-five thousand pounds sterling (£103,535,000).

**Musselburgh Flood Protection Scheme**

We are writing to object to the recently published Musselburgh Flood Protection Scheme. Although our property is not at risk of flooding, we do regularly use the amenities currently within Musselburgh including walking along and enjoying the river and sea front and in particular the bird life.

We have been actively engaged with all the “consultation events” and have on a number of occasions expressed our concerns, however these do not seem to have been taken seriously.

We object to the published scheme because:

**Firstly: the brief.** The scheme is predicated on a once in 200 year event. The question must be asked; is this necessary?, and whether the scheme might look very different if it was designed for a once in 75 or 100 year event?

**Secondly: lack of weight given to other options.** Other options that don't appear to have been given due and full consideration include: nature based solutions, individual flood management at property level and the use of demountable flood protection and/or a combination of all these measures. A range of options/schemes should have been presented as per Scottish Government guidance.

**Thirdly: the design approach.** The current proposals are based primarily on unimaginative hard, high carbon, engineering. This is perhaps not surprisingly when the lead consultants are a firm of engineers who have designed several such schemes throughout Scotland. It is such an approach which can actually exacerbate the problem. Straightening and canalising rivers has been the cause of flooding problems in other areas while a holistic approach including re-wilding projects, extensive tree planting in upland areas and introducing sacrificial flood plains etc. have a positive effect both on the environment and in reducing

flood risk. We should be exploring sustainable low carbon environmentally sensitive solutions first. Additionally there is both a lack of any real high quality architectural and urban design input, it being entirely engineer led, as well as a lack of any real attempt at community input.

**Fourthly: effect on the existing environment.** The number of trees that will be felled and the effect on both the natural and urban environment of Musselburgh will be enormous, completely changing the unique character of the place. Any newly planted and/ or replacement trees will take decades to become mature.

**Fifthly:cost.** As tax payers we believe that the cost of the scheme is escalating out of all proportion at a time when council funding is decreasing. Although money will come from Scottish Government, we consider prioritising a projected once in 200 year flooding event, with all that entails, is the wrong priority at time when so many services are being cut.

**Finally: disruption.** There will be massive disruption for many years for a project of this size within Musselburgh town and surrounding areas including Inveresk. As a conservation village Inveresk already suffers from serious issues with regard to both the volume of traffic and speeding within the village. It was noted that during the construction of new houses in the area and the creation of the new lagoons at Musselburgh, heavy lorries were regularly going though the village. This went on for 18 months. If the flood prevention project goes ahead this could happen again as the road though Inveresk is used as one of the main arteries in and out of Musselburgh.
